 - (iii) Column 1 ("F") of Schedule 1 be deleted and substituted by "Wickford Central to rear of and on the eastern side of the High Street, south of the railway including access and exit ways and the service roads, also known as Wickford Main and Ladygate Car Parks".



On 28 April 2004, when this Notice comes into force, these charges will be increased to £218.00 per hall year for Billericay car parks and £197.00 per half year for Basildon and Wickford (including the Civil Service Block, Gloucester Park).

(b) To introduce charges for season tickets when this Notice comes into force on 26 April 2004 as follows:
