### <u>THE SOUTH ESSEX PARKING PARTNERSHIP</u> (CHELMSFORD CITY COUNCIL) (WAITING, LOADING AND PARKING CONSOLIDATION) (VARIATION NO.14) ORDER 2013

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011(and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and Part IV of Schedule 9 of the Act and of all other enabling powers.

- This Order shall come into operation for all purposes on the 11<sup>th</sup> day of November 2013 and may be cited as The South Essex Parking Partnership (Chelmsford City Council) (Waiting, Loading and Parking Consolidation) (Variation No.14) Order 2013.
- 2. With effect from the date set out in Article 1 above, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009 ("the 2009 Consolidation Order") shall have effect as though in Schedule 2 to that Order ("Properties the residents of which are eligible to apply for parking permits") were modified by the addition of the following properties:-

Zone 7 Fell Christy – All residential properties.

3. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 3 to that Order ("Waiting, Stopping, Loading and Unloading Restrictions") -

- the references to those roads or parts of roads already in that Schedule and indicated in Schedule A to this Order were deleted and the references in Schedule B were substituted therefore; and
- (ii) the references to those roads or parts of roads not already included in that Schedule and indicated in Schedule B to this Order were inserted therein.
- 4. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 4 to that Order ("Permit Parking Places")
  - the references to those roads or parts of roads already in that Schedule and indicated in Schedule C to this Order were deleted and the references in Schedule D were substituted therefore; and
  - (ii) the references to those roads or parts of roads not already included in that Schedule and indicated in Schedule D to this Order were inserted therein.
- 5. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 9 to that Order ("Limited Waiting Parking Places") the reference to those roads or parts of roads indicated in Schedule E to this Order were inserted therein.
