

THE SOUTH ESSEX PARKING PARTNERSHIP
(CHELMSFORD CITY COUNCIL)
(WAITING, LOADING AND PARKING CONSOLIDATION)
(VARIATION NO.20) (PART 1) ORDER 2014

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and Part IV of Schedule 9 of the Act and of all other enabling powers.

1. This Order shall come into operation for all purposes on the 30th day of October 2014 and may be cited as The South Essex Parking Partnership (Chelmsford City Council) (Waiting, Loading and Parking Consolidation) (Variation No.20) (Part 1) Order 2014.
2. With effect from the date set out in Article 1 above, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009 ("the 2009 Consolidation Order") shall have effect as though in Schedule 3 to that Order ("Waiting, Stopping, Loading and Unloading Restrictions") -
 - (i) the references to those roads already in that Schedule and indicated in Schedule A to this Order were deleted and the references in Schedule B to this Order were substituted therefor; and
 - (ii) the references to those roads not already included in that Schedule and indicated in Schedule B to this Order were inserted therein.
3. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 4 to that Order ("Permit Parking Places") the reference to those roads already in that Schedule and indicated in Schedule C to this Order were deleted and the reference in Schedule D to this Order were substituted therefor.

Wheatfield Way Chelmsford	No Waiting At Any Time	South side from a point 8 metres east of its junction with Nelson Grove in an easterly direction for a distance of 47 metres
Woodham Road (access road leading to Forge Cottage & Garage) Battlesbridge	No Waiting Mon-Fri 7am-8am	Both sides from its western junction with Woodham Road for its entire length to its eastern junction with Woodham Road, including the cul-de-sac end.
Writtle Road Chelmsford	No Waiting Mon-Sat 7.30am-7pm	South side from a point 17 metres east of its junction with Robjohns Road in a westerly direction for a distance of 46 metres
Writtle Road (access road leading to the Lodge House) Chelmsford	No Waiting At Any Time	Both sides from the roundabout at its junction with Writtle Road / Parkinson Drive in a southerly direction for a distance of 11 metres.
