

THE SOUTH ESSEX PARKING PARTNERSHIP
(CHELMSFORD CITY COUNCIL)
(WAITING, LOADING AND PARKING CONSOLIDATION)
(VARIATION NO.23) ORDER 2014

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and Part IV of Schedule 9 of the Act and of all other enabling powers.

1. This Order shall come into operation for all purposes on the 17th day of November 2014 and may be cited as The South Essex Parking Partnership (Chelmsford City Council) (Waiting, Loading and Parking Consolidation) (Variation No.23) Order 2014.

2. With effect from the date set in Article 1 above, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009 ("the 2009 Consolidation Order") shall have effect as though Schedule 2 to that Order ("Properties the Residents of which are eligible to apply for Parking Permits") were modified by the addition of the following properties:-

Zone 5
Shelley Road – All residential properties
Morris Road – All residential properties

Zone 7
Pottery Lane – All residential properties
Broomfield Road – Nos. 207 – 223 odds inclusive

3. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 4 to that Order ("Permit Parking Places") the references to the roads indicated in the Schedule to this Order were inserted therein.

Added to Schedule 4 to the 2009 Consolidation Order

LOCATION	ZONE	RESTRICTION	EXTENT
Morris Road Chelmsford	5	Permit Parking Area Mon-Sat 8am-6pm	Both sides from its junction with Shelley Road in a southerly direction to its end
Shelley Road Chelmsford	5	Permit Parking Area Mon-Sat 8am-6pm	Both sides from a point 15 metres north of its junction with Byron Road (west section) for its entire length to a point 10 metres north of its junction with Byron Road (east section)
Pottery Lane Chelmsford	7	Permit Parking Area Mon-Fri 8am-6pm	Both sides from a point 15 metres west of its junction with Broomfield Road in a westerly direction to its end
