THE SOUTH ESSEX PARKING PARTNERSHIP (CHELMSFORD CITY COUNCIL) (WAITING, LOADING AND PARKING CONSOLIDATION) (VARIATION NO.28) ORDER 2015

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011(and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and Part IV of Schedule 9 of the Act and of all other enabling powers.

- This Order shall come into operation for all purposes on the 9th November day of 2015 and may be cited as The South Essex Parking Partnership (Chelmsford City Council) (Waiting, Loading and Parking Consolidation) (Variation No.28) Order 2015.
- 2. With effect from the date set in Article 1 above, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009 ("the 2009 Consolidation Order") shall have effect as though Schedule 2 to that Order ("Properties the Residents of which are eligible to apply for Parking Permits") were modified by the addition of the following properties:-

Acres End - All residential properties Canterbury Way – All residential properties Lichfield Close – All residential properties St Fabians Drive – All residential properties Roxwell Road – nos. 28 & 30 Zone 10 Tees Road – All residential properties Lawn Lane – nos. 9 -25 odds

- 3. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 3 to that Order ("Waiting, Stopping, Loading and Unloading Restrictions") the references to those roads indicated in Schedule A to this Order were inserted therein.
- 4. With effect from the date set out in Article 1 above, the 2009 Consolidation Order shall have effect as though in Schedule 4 to that Order ("Permit Parking Places") the references to those roads indicated in Schedule B to this Order were inserted therein.
