THE BOROUGH OF FAREHAM (VARIOUS ROADS) (PROHIBITION OF MOTOR VEHICLES AND CYCLES ON GRASS VERGES) (CONSOLIDATION) ORDER 2007

The Council of the Borough of Fareham (hereinafter referred to as "The Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Council of the County of Hampshire in exercise of the powers of the said County Council under Section 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), the Road Traffic Act 1991 ("the 1991 Act") and of all other enabling powers after consultation with the chief officer of police in accordance with part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1. This Order shall come into force on 2nd April 2007 and may be cited as the Borough of Fareham (Various Roads)(Prohibition of Motor Vehicles and Cycles on Grass Verges (Consolidation) Order 2007.

Intrepretation

2. (i) In this Order:-

"grass verge" means any unmetalled area between the edge of the carriageway and the highway boundary

"motor vehicle" has the same meaning as that in Section 136 of the Road Traffic Regulation Act 1984

"pedal cycle" means a unicycle, bicycle, tricycle, or a cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purpose of the Road Traffic Regulation Act 1984;

"parking attendant/civil enforcement officer" means a person authorised by or on behalf of the Council to supervise any parking place or enforce restrictions indicated on the Plans;

- (ii) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
- (iii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Restriction

- No person shall drive or park any motor vehicle or cycle on the areas of grass verges in the roads specified in the Schedule to this Order.
- 4. Insofar as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act and existing at the time when this Order comes into operation and which imposes a restriction or prohibition on waiting by vehicles other than stage carriages or express carriages in a bus stop area or grants an exemption from such restriction or prohibition that provision of that Order shall prevail.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

Waiver certificates

- 6. The Council may issue a waiver certificate to park on a grass verge in exceptional circumstances on receipt of written application with at least 5 working days notice and may impose terms and conditions as appropriate.
- 7. A charge may be made for a waiver certificate as determined by the Council.
- 8. A waiver certificate may be cancelled at any time at the sole discretion of the Council and shall thereupon immediately cease to be valid. Notification of such cancellation shall be in writing to the holder of the waiver certificate at any address that the Council believes to be that person's address and the waiver certificate shall forthwith be surrendered to the Council.

Contravention

9. If a vehicle is left in a grass verge on any road or length of road in contravention or without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable and/or the vehicle may be removed from that location.

Penalty Charge Notice

10. In the case of vehicles in respect of which a penalty charge may have been incurred, it shall be the duty of the Parking attendant / civil enforcement officer to attach to the

vehicle in a conspicuous position a notice which shall include the following particulars:

- (a) the registration mark of the vehicle or, where the vehicle is being used under a trade license, the number of the trade plate carried by the vehicle;
- (b) the grounds on which the parking attendant / civil enforcement officer believes that a Penalty Charge is payable in respect of that vehicle;

(c) the amount of Penalty Charge required to be paid;

- that if the penalty charge is paid before the end of the period of 14 days beginning with the date of the notice, the amount of the penalty charge will be reduced by the specified proportion or amount;
- (e) that if the penalty charge is not paid before the end of the 28 day period a Notice to owner may be served by the Council on the person appearing to be the owner of the vehicle; and
- (f) the address to which payment of the Penalty Charge must be sent.

Manner of Payment of Penalty Charge and Reduced Penalty Charge

- 11. The owner of a vehicle in respect of which the Penalty Charge has been incurred shall pay the Penalty Charge to the Council by cheque or postal order which shall be delivered or sent by post so as to reach the Council's Offices within 28 days of the issue of the penalty charge OR in cash in person at the Council's Offices not later than as aforesaid OR by credit card or debit card OR electronically through the Council's web site.
- 12. If the Penalty Charge is paid before the end of the period of 14 days beginning with the date of the Penalty Charge Notice, the amount of the Penalty Charge will be reduced by 50%.
- 13. Payment shall be received not later than 1600 hours on the 28th day following the day on which such Penalty Charge was incurred or the 14th day following the day on which the Charge was incurred if the reduced charge is paid PROVIDED THAT if the said 28th or 14th day falls upon a day on which the Councils Offices are closed the period within which payment of the said Penalty Charge shall be made to the Council shall be extended until 1600 hours on the next full day on which the Councils Offices are open.
- 14. If the owner fails to pay the penalty charge by the end of the 28 day period, a notice of owner may be served; and if the charge is not paid within a further 28 days it may be increased by 50% on the issue of a charge certificate in accordance with the provisions of paragraph 6 of schedule 6 of the 1991 Act.
- 15. Continuing failure to pay the penalty charge may result in a judgement in the County Court against the owner to enable the Council to recover the payments due.

Indications As Evidence

16. The particulars given in the penalty charge notice attached to a vehicle in accordance with Article 10 shall be treated as evidence in any proceedings relating to failure to pay such penalty charge.

Restriction On Removal Of Notices

17. Where a penalty charge notice has been attached to a vehicle in accordance with the provisions or Article 10, no person, not being the driver of the vehicle, a police constable in uniform, a parking attendant/civil enforcement officer or some other person duly authorised by the Council, shall remove the notice from the vehicle unless authorised to do so by the keeper of the vehicle.

Removal of vehicle

- 18. Where a parking attendant/civil enforcement officer in uniform has removed or caused to be removed a vehicle in accordance with Article 9:-
 - (a) he shall provide for the safe custody of the vehicle;
 - (b) the Council shall be entitled to recover from the person responsible such charges in respect of removal, storage and disposal of the vehicle as it might prescribe from time to time;
 - (c) the provisions of the Road Traffic Regulation Act 1984 as amended shall apply to the disposal of any such vehicle removed by or on behalf of the Council pursuant to this Article.

Nothing in this Article shall apply in respect of a vehicle displaying in the relevant position a valid disabled person's badge issued by any local authority.
