

**THE KENT COUNTY COUNCIL (THE DISTRICT OF SHEPWAY)
(GUILDHALL NORTH PARKING ZONE) (AMENDMENT 1) ORDER 2016**

ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL acting as the local traffic authority and in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. CITATION AND COMMENCEMENT:

This Order may be cited as "The Kent County Council (The District of Shepway) (Guildhall North Parking Zone) (Amendment 1) Order 2016" and shall come into effect on the 29th August 2016.

2. REVOCATIONS:

This Order shall revoke all restrictions in any of the roads or lengths of road mentioned herein from the "*The Kent County Council (The District of Shepway) (Restrictions and Prohibitions of Waiting, Loading and Unloading) Consolidation Order 2010*" and all its subsequent amendments and consolidates them in this Order.

3. INTERPRETATION:

- I. In this Order the "Principal Order" shall mean the "The Kent County Council (The District of Shepway) (Guildhall North Parking Zone) Consolidation Order 2015", *as amended*.
- II. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- III. Any reference in this Order to any enactment shall be construed as a reference to that enactment, as amended by any subsequent enactment.
- IV. The prohibitions, restrictions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.
- V. In this Order, Zone E means the list of roads in the Principal Order with the addition of Millfield, Folkestone.

4. PROHIBITION OF WAITING

The contents of Schedule 1 shall be inserted into Schedule 1 of the Principal Order.

5. PROVISION OF PARKING SPACES

The contents of Schedule 2 shall be inserted into Schedule 2 of the Principal Order.

PROHIBITION OF WAITING AT ANY TIME

ROADS IN FOLKESTONE

Millfield

North-east side

- from its junction with Cheriton Road for a distance of 17 metres in a westerly direction.

South-east side

- from its junction with Cheriton Road for a distance of 17 metres in a westerly direction

North-west side

- from its junction with Cheriton Gardens for a distance of 15 metres in an easterly direction.

South-west side

- from its junction with Cheriton Gardens for a distance of 15 metres in an easterly direction.
