(THE DISTRICT OF SHEPWAY, VARIOUS ROADS)
(RESTRICTIONS AND PROHIBITIONS OF WAITING, LOADING AND UNLOADING)
(AMENDMENT NO 3) ORDER 2017

ROAD TRAFFIC REGULATION ACT 1984

The Kent County Council acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53 and 122 of the Road Traffic Regulation Act 1984 ('the act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with part iii of Schedule 9 to the act, hereby make the following order:-

1. CITATION AND COMMENCEMENT:

This order may be cited as "The Kent County Council (The District of Shepway, Various Roads) (Restriction and Prohibitions of Waiting, Loading and Unloading) (Amendment No 3) Order 2017" (this Order) and shall come into effect on the **15 January 2018**.

2. INTERPRETATION:

- I.** In this order the "Principal Order" shall mean the "The Kent County Council (The District of Shepway) (Restrictions and Prohibitions of Waiting, Loading and Unloading) Consolidation Order 2017", as amended.
- II.** Except where otherwise stated, any reference in this order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
- III.** Any reference in this Order to any enactment shall be construed as a reference to that enactment, as amended by any subsequent enactment.
- IV.** The prohibitions, restrictions and requirements imposed by this order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this order is without prejudice to the provisions of any other enactment.

3. PROHIBITION OF WAITING AT ANY TIME.

The contents of Schedule 1 shall be inserted into Schedule 1 of the Principal Order.

4. PROHIBITION OF WAITING BETWEEN 08.00 & 18:00 HOURS, ALL DAYS

The contents of Schedule 2 shall replace the contents of Schedule 7 of the Principal Order.

5. LIMITED WAITING PARKING PLACES – ALL DAYS.

The contents of Schedule 3 shall be inserted into Schedule 25 of the Principal Order.

SCHEDULE 1

PROHIBITION OF WAITING AT ANY TIME

ROADS IN FOLKESTONE

Augusta Gardens

Both sides for its entire length.

Charlotte Street

North east side, from its junction with Dover Road for a distance of 6.5 metres in a south easterly direction.

South west side, from its junction with Dover Road for a distance of 60 metres in a south easterly then south westerly direction.

North western side, from its junction with Harvey Street for distance of 5 metres in north easterly direction.

South eastern side, from its junction with Harvey Street for distance of 102 metres in north easterly direction.

Jointon Road

Both sides on its centre line from its junction with Earls Avenue for a distance of 17 metres in south westerly direction.

Both sides on its centre line from its junction with Shomcliffe Road for a distance of 17.5 metres in south westerly direction.

East side, from the projected northern kerb line of Tram Road for a distance of 5 metres in north easterly direction.

East side, from the projected southern kerb line of Tram Road for a distance of 8 metres in south westerly direction.

Muddles Passage

Both sides for its entire length.

Sandgate Esplanade

North side, from the projected western kerb line of Sunnyside Road for a distance of 10 metres in a westerly direction.

Sandgate Road

(North side)

From a point 5 metres west of the western side of the ingress of Holy Trinity Church to point 5 metres east of the eastern side of that junction.

From a point 5 metres west of the western side of the egress of Holy Trinity Church to point 5 metres east of the eastern side of that junction.

ROADS IN HYTHE

Martins Way

West side, from its junction with Grebe Crescent to Martins Way.

SCHEDULE 2

PROHIBITION OF WAITING BETWEEN 08.00 & 18:00 HOURS, ALL DAYS

ROADS IN FOLKESTONE

Castle Bay

Both sides, on its centre line from its junction with Sandgate Esplanade for distance of 15 metres in northerly direction.

Dover Road

South east side, from a point 10.7 metres west of its junction with Harbour Way to point 7.6 metres east of its junction with Charlotte Street.

Foreland Avenue

Both sides from its junction with Wear Bay Road, west for distance of 20 metres.

Shorncliffe Road

Both sides, from a point 24 metres east of the centre of Coolinge lane, west to the centre line of Shorncliffe Crescent.

Wear Bay Road

North west side then north side, from its junction with Wear Bay Crescent, to a point 15 metres north west of its junction with Hollands Avenue.

ROADS IN HYTHE

Bartholomew Street

North side, from its junction with Dental Street for a distance of 16.5 metres west of that junction
