THE BOROUGH COUNCIL OF GATESHEAD (GATESHEAD TOWN CENTRE) TRAFFIC REGULATION ORDER 2014

The Borough Council of Gateshead ("the Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 32 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act'), and by virtue of the Traffic Management Act 2004, and of all other enabling powers hereby make the following Order: -

PARTI

Citation and Revocation

- This Order may be cited as "The Borough Council of Gateshead (Gateshead Town Centre) Traffic Regulation Order 2014" and shall come into operation on 18th November 2014.
- 2. This Order shall revoke on the date it comes into operation, the following Orders:-
 - 1. The Borough Council of Gateshead (Gateshead Town Centre) Experimental Traffic Order 2013;
 - 2. The Borough Council of Gateshead (Gateshead Town Centre) Experimental (Amendment No 1) Traffic Order 2013;
 - 3. The Borough Council of Gateshead (Gateshead Town Centre) Experimental (Amendment No 2) Traffic Order 2013.

PART II

Interpretation

2. In this Order except where the context requires, the following expressions have the meaning hereby respectively assigned to them: -

"civil enforcement officer" means a person authorised by or on behalf of theCouncil under Section 76 of the Traffic Management Act 2004 to supervise and enforce the road traffic contraventions for which Gateshead Council is the enforcement authority;

"disabled parking bay" means any area of a disabled parking place which is provided for the leaving of a disabled person's vehicle and indicated by markings on the surface of the carriageway;

"disabled parking place" means an area of the highway designated as a parking place by Part V Article 1 to this Order and indicated by markings on the surface of the carriageway;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"disabled person's parking disc" means a disc issued by a local authority (125 millimetres square) coloured blue if issued on or after 1st April 2000 or orange if issued before that date and is capable of showing the quarter hour period during which a period of waiting has begun;

"driver" in relation to a vehicle parked in a parking place means the person driving the vehicle at the time it was left in the parking place;

"exemption certificate" means an authorisation in writing granted by the Service Director Transport Strategy of the Council or their duly authorised representative allowing a vehicle to wait in contravention of the provisions of this Order subject to and in accordance with any specified conditions or limitations contained within that authorisation;

"goods vehicle" means a vehicle which is constructed or adapted for use for the carriage of goods of any description and is not drawing a trailer;

"hackney carriage" has the same meaning as in the Town Police Clauses Act 1847;

"parking place" means an area of the highway designated as a parking place by Part V Articles 1, 2 and 3 to this Order;

"parking bay" means any area of a parking place which is provided for the leaving of vehicles and indicated by markings on the surface of the parking place;

"penalty charge notice" 'PCN' means a notice issued by a Civil Enforcement Officer pursuant to the provisions of Section 78 of the 2004 Act and Regulations made thereunder;

"postal operator" means a person who provides the service of conveying postal packets from one place to another by post or any of the related services of receiving, collecting, sorting and delivering of such packets as defined in section 125 of the Postal Services Act 2000;

"postal service" means the service of conveying postal packets from one place to another by post and the related services of receiving, collecting and delivering of such packets and any other service which relates to any of those services and is provided in conjunction with any of them as defined in section 125 of the Postal Services Act 2000;

[&]quot;relevant position" means-

- (a) the disabled person's parking disc, disabled person's badge or exemption certificate is exhibited on the dashboard of fascia of the vehicle; or
- (b) in the case of a vehicle not fitted with a dashboard or fascia, the disabled person's parking disc, disabled person's badge or exemption certificate is exhibited in a conspicuous position on the vehicle

so that the front of the disabled person's parking disc, disabled person's badge or exemption certificate is clearly legible from outside of the vehicle;

"registered keeper" means the person in whose name the vehicle was registered under the Vehicle Excise and Registration Act 1994;

"vehicle" means any motor car, motor cycle and invalid carriage having the same meaning respectively as in Section 136 of the Road Traffic Regulation 1984 and any goods vehicle (being a motor vehicle not exceeding 30 unit unladen weight which is constructed or adapted for use for carriage of goods of any description.

PART III Loading Restrictions

Goods Vehicle Only Loading Bay operating from 6.30pm to 10.00am and 4.30pm to 12.00am (Midnight) on All Days

1. Save as provided in Part III Article 5 and Part V Article 7 to this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle other than a goods vehicle to wait for the purpose of loading or unloading only between the hours of 6.30pm to 10.00am and 4.30pm to 12.00am (Midnight) on all days in or on the lengths of road specified in Part 1 to Schedule 1 to this Order.

Loading Bay operating from 6.30pm to 10.00am and 4.30pm to 12.00am (Midnight) on all days

3Save as provided in Part III Article 5 and Part V Article 7 to this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait or load at any time other than for the purpose of loading or unloading only between the hours of 6.30pm to 10.00am and 4.30pm to 12.00am (Midnight) on all days in or on the lengths of road specified in Part 2 to Schedule 1 to this Order.

Loading Bay operating 7.00am to 10.30am and 2.20pm to 12.00am (midnight) on all days

3A Save as provided in Part III Article 5 and Part V Article 7 to this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait or load at any time other than for the purpose of loading or unloading only between the hours of 7.00am to 10.30pm and 2.20pm to 12.00am (midnight) on all days in or on the lengths of road specified in Part 3 to Schedule 1 to this Order.

No Waiting and No Loading / Unloading at Any Time

4. Save as provided in Part III Article 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait, load or unload at any time in or on the lengths of road specified in the Schedule 5 to this Order.

Exemptions

- 5. Nothing in Part III Articles 1, 3, 3A and 4 to this Order shall render it unlawful to cause or permit any vehicle to wait or otherwise be in the lengths of road referred to therein for so long as maybe necessary to enable:-
- (a) the picking up or setting down of passengers;
- (b) the vehicle, if it cannot be conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely:-
 - (i) building or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said roads;
 - (iv) the laying, erection, alteration or maintenance in or on land adjacent to the said length of road of any sewer, main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984;
- (c) the vehicle if it cannot conveniently be used for such purpose in any other road be used in the service of a local authority or water authority in pursuance of statutory duties;
- (d) to enable a vehicle to be used by a postal operator in the provision of a postal service;
- (e) the vehicle to wait upon an authorised parking place or being a hackney carriage waiting at a duly authorised hackney carriage rank;
- (f) any police, fire brigade or ambulance vehicle on emergency call or being used for such purposes;

- (g) any vehicle used in pursuance of statutory powers or duties;
- (h) any vehicle displaying a valid exemption certificate in the relevant position.

PART IV

Waiting Restrictions

No Waiting at Anytime

1. Save as provided in Part IV Article 3 to this Order no person shall, except upon the direction or with the permission a police officer in uniform or a civil enforcement officer, cause or permit any vehicle to wait at anytime in or on the lengths of road listed in Schedule 2 to this Order.

Limited Waiting for 2 hours with no return in 2 hours Monday to Saturday (inclusive)

- 2. Save as provided in Part IV Article 3 and Part V Article 7 to this Order no person shall, except upon the direction or with the permission a police officer in uniform or a civil enforcement officer, cause or permit any vehicle to wait between Monday to Saturday (Inclusive) in or on the lengths of roads listed in Schedule 3 to this Order:
 - (a) for a longer period than two hours;
 - (b) if a period of less than two hours has elapsed since the termination during the said hours, of the last period of waiting (if any) by that vehicle on the same length of road.

Exemptions

- 3. (1) Nothing in Part IV Articles 1 and 2 to this Order shall render it unlawful to cause or permit any vehicle to wait in or on the lengths of road referred to therein for so long as may be necessary to enable:-
 - (a) the picking up or setting down of passengers;
 - (b) goods to be loaded onto or unloaded from the vehicle;
 - (c) the vehicle, if it cannot be conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely-
 - (i) building or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said roads;
 - (iv) the laying, erection, alteration or maintenance in or on land adjacent to the said length of road of any sewer, main pipe or

apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984:

- (d) the vehicle if it cannot conveniently be used for such purpose in any other road be used in the service of a local authority or water authority in pursuance of statutory duties;
- (e) to enable a vehicle to be used by a postal operator in provision of a postal service;
- (f) the vehicle to wait upon an authorised parking place or being a hackney carriage waiting at a duly authorised cab rank;
- (g) any police, fire brigade or ambulance vehicle on emergency call or being used for such purposes;
- (h) any vehicle used in pursuance of statutory powers or duties;
- (i) a vehicle waiting on a parking place duly authorised by an Order made under the Act provided that the vehicle is parked in accordance with the provisions of such an Order
- (j) any vehicle displaying a valid exemption certificate in the relevant position.
- (2) Nothing in Part IV Articles 1 and 2 to this Order shall render it unlawful to cause or permit a vehicle which displays in the relevant position a disabled persons badge and disabled persons parking disc (on which the driver or other person in charge of the vehicle, has marked the quarter hour period during which the period of waiting began) to wait in the lengths of roads referred to in that Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day).

PART V

Designated Parking Bays

- The lengths of road specified in Schedule 6 to this Order are hereby designated as a parking place under section 32 of the Act, subject to the provisions in this Order, for disabled persons' vehicles between the hours of 10am to 4.30pm on all days.
- 2. No person shall, except upon the direction or with the permission of a police officer in uniform or a civil enforcement officer cause or permit any vehicle other than a disabled persons vehicle to wait in or on a disabled parking place.
- Any vehicle left to stand within a disabled parking place or bay should display
 a disabled persons badge in the relevant position during the whole period the
 vehicle is left to stand in the disabled parking place or bay.

- 4. The lengths of road specified in Schedule 3 to this Order are hereby designated as a parking place under section 32 of the Act, for all vehicles operating on such days and such hours as specified in that Schedule.
- 5. The lengths of road specified in Schedule 4 to this Order are hereby designated as a parking place under section 32 of the Act, for all vehicles operating on such days and such hours as specified in that Schedule.
- 6. Every vehicle left in any parking place designated under this Order shall stand so that the vehicle is wholly within the parking place or if the parking place is so marked within any bay.
- 7(1) Any person duly authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary:-
 - (a) for the purposes of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or maintenance in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line, traffic sign or parking meter;
 - (c) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (d) on an occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (e) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on the other special occasions
- (2) A police constable in uniform may suspend for not longer than 24 hours the use of a parking place or part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (3) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (2) of this Article shall thereupon:-
 - (a) place or cause to be placed over the sign relating to the parking place or parking bay hoods or other covers indicating that the use of the parking place or parking bay is suspended and that waiting by vehicles is prohibited; and
 - (b) place or cause to be placed in or adjacent to any part of that parking place which is not a parking bay and use of which is suspended by a traffic sign indicating that waiting by vehicles is prohibited.

- (4) On any suspension of the use of a parking place or any part thereof in accordance with the provisions of paragraph (1) of this Article, any person duly authorised by the Council may temporarily remove any traffic sign relating to any parking place or parking bay, as the case may be, and any post, bracket or other support on which that parking sign is fitted and shall thereupon place or cause to be placed in or adjacent to that parking place or parking bay a traffic sign giving the indication referred to in paragraph (3)(b) of this Article.
- (5) No person shall cause or permit a vehicle to be left -
 - (a) in a parking place or a parking bay during such period as there is over the parking sign relating to that place or bay a hood or other cover indicating that the use of the parking place or bay is suspended or during such period as there is in or adjacent to that place or bay a traffic sign placed in pursuance of paragraph (4) of this Article.
 - (b) in any part of the parking place, not being a parking bay, during such period as there is in or adjacent to that part of the parking place a traffic sign placed in pursuance of paragraph (3)(b) of this Article PROVIDED THAT nothing in this paragraph shall render it unlawful to cause or permit a vehicle to be left in the parking place or parking bay during either such period as is referred to in sub-paragraph (a) of this paragraph or in the part of a parking place not being a parking bay, during such period as is referred to in sub-paragraph (b) of this paragraph if:-
 - (i) the vehicle is left with the permission of the person suspending the use of the parking place or the part thereof in pursuance of paragraph (1) of this Article, or
 - (ii) of a police constable in uniform or a civil enforcement officer.

PART VI

Amendments to The Borough Council of Gateshead (Hopper Street Gateshead Area) (No Waiting At Any Time) Order 2007

- The Borough Council of Gateshead (Hopper Street Gateshead Area) (No Waiting At Any Time) Order 2007 is amended as follows:-
- 2. In Part 2 to Schedule 3 'No Waiting at Any Time', the Item relating to 'Swan Street' and the Item relating to 'Hopper Street', shall be revoked in their entirety.
- 3. In Part 3 to Schedule 3 'No Waiting Between 8.00am and 6.00pm (Monday Saturday)', the Item relating to 'Hopper Street', shall be revoked in its entirety.
- 4. In Part 6 to Schedule 3 'Loading / Unloading Outside the hours of 4.30pm and 10.00am Monday to Saturday', the Item relating to the 'Unnamed Access Road (known locally as Grey Nags Lane)', shall be revoked in its entirety.

PART XIII

1. The Borough Council of Gateshead (Jackson Street Area Gateshead) Traffic Regulation Order 2003 is hereby revoked in its entirety.

PART XIV Contraventions and Enforcement

1. If a vehicle is left in a parking place in contravention of any of the provisions of this Order, other than a provision relating to a moving traffic offence, a penalty charge shall be payable.

- 2. If the penalty charge becomes payable in respect of any vehicle, a civil enforcement officer or other person duly authorised by the Council may issue a PCN in accordance with Section 78 of the 2004 Act.
- 3. Where a penalty charge notice has been attached to a vehicle, no person, not being the driver of the vehicle, or a parking attendant, shall remove the notice from the vehicle unless authorised to do so by the driver.
- 4. For the purposes of this Order the driver shall be assumed to be the registered keeper unless such person can satisfy the Council that he was not in fact driving the vehicle at the relevant time.
- 5. If the driver of a vehicle to which a PCN has been issued in accordance with the provisions of Part XIV Article 2 of this Order fails to pay the Penalty Charge, the Council may enforce the penalty charge in accordance with any regulations made under Section 82 of the 2004 Act.

PART XV

Drop off and Pick Up Bay

1. Save as provided in Part III Article 5 and Part V Article 7 to this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement, cause or permit any vehicle to stop in or on the lengths of road specified in Schedule 4 to this Order other than for a period not exceeding 10 minutes for the purpose of picking up of persons or goods only.

PART XVI

Amendments to the Borough Council of Gateshead (Prohibition of Stopping and Waiting, Except Taxis) Order 2007

- The Borough Council of Gateshead (Prohibition of Stopping and Waiting, Except Taxis Order) Order 2007 is amended as follows:-
