THE KENT COUNTY COUNCIL (VARIOUS ROADS, GRAVESEND) (STREET PARKING PLACES) (AMENDMENT No. 2) ORDER 2007

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2) and 53 of the Road Traffic Regulation Act 1984, ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

A - the Kent County Council (Various Roads, Gravesend) (Street Parking Places) Order 2005 shall have effect as though:

In the Articles to the Order

DISABLED PERSONS VEHICLE PARKING PLACES

Article 19 shall be deleted and replaced with

- 19 (1) SAVE as provided in Part D of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a parking attendant, cause or permit any vehicle to wait in any of the parking places specified in Part 1 of the Fourth Schedule to this Order unless it is a disabled persons vehicle which displays in the relevant position a disabled person's badge.
 - (2) SAVE as provided in Part D of this Order
 - (a) no person shall, except upon the direction or with the permission of a police constable in uniform or of a parking attendant, cause or permit any vehicle to wait in any of the parking places specified in Part 2 of the Fourth Schedule to this Order unless it is a disabled persons vehicle which displays in the relevant position a disabled person's badge; and
 - (b) no disabled persons vehicle shall so wait
 - (i) for a longer period than three hours, or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.

In the Schedules to the Order

PAY AND DISPLAY PARKING

QUEEN STREET

The following to be added to Part 1 of the First Schedule in correct alphabetical sequence -

QUEEN STREET

On the eastern side

(a) between points 21 metres south of the junction with Crooked Lane and The Terrace and 2 metres north of the southern building line of 13-24 Queen Street;

(b) from a point 2 metres south of the northern building line of 1 - 12 Queen Street for a distance of 21 metres in a southerly direction.

TERRACE STREET

The following to be added to Part 1 of the First Schedule in correct alphabetical sequence -

- TERRACE STREET (1) On the southern side between points 14 metres and 30 metres east of the eastern kerb line of Queen Street.
 - (2) On the eastern side
 - (a) between points 2 metres and 18 metres south of the projected southern kerbline of Terrace Street;
 - (b) at an angle to the kerb between points 26 metres and 38 metres south of the projected southern kerbline of Terrace Street.
