THE KENT COUNTY COUNCIL

(VARIOUS ROADS, GRAVESEND) (STREET PARKING PLACES)

(Amendment No 1 Order 2014)

The Kent County Council, in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1) and (2), 32(1), 35(1) and 124 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order.

CITATION, COMMENCEMENT and REVOCATIONS

- This Order shall come into operation on 24th March 2014 and may be cited as "The Kent County Council (Various Roads, Gravesham) Street Parking Places (Amendment No 1 Order 2014).
- 2. The Orders set out in the first column of the Table shall be modified or revoked to the extent set out in the second column of the table.

The Kent County Council (Various Roads, Gravesend) (Street Parking Places) Order 2005 shall continue to have effect but with the following amendments:-

- (i) In the Second Schedule Part 1 "Zones for Residents' Permits"
- (a) The table under the heading **Zone**: (South-east) Code B shall have deleted from both columns the street names "Brandon Street", "Cutmore Street" and "Spencer Street". The amended table will read as follows:-

PART 2

STREET OR LENGTH OF STREET

DESIGNATED A PARKING PLACE AT ALL TIMES
WHERE PARKING IS RESTRICTED TO RESIDENTS' OR VISITORS' PERMIT
HOLDERS ONLY BETWEEN THE HOURS OF MIDNIGHTS AND 8AM AND BETWEEN
6.30PM AND MIDNIGHT ON ALL DAYS

And

WHERE PARKING IS LIMITED TO 1 HOUR (NO RETURN WITHIN 2 HOURS)
BETWEEN 8.00 am and 6.30 pm ON ALL DAYS

EXCEPT FOR RESIDENTS' OR VISITORS PERMIT HOLDERS

ARTHUR STREET On the northern side

- a) From a point 17 metres east of its junction with Darnley Road to a point 12 metres west of its junction with Cambrian Grove
- From a point 17 metres east of its junction with Cambrian Grove to a point 12 metres west of its junction with Cutmore Street
- From a point 12 metres east of its junction with Cutmore Street to a point 10 metres west of its junction with Brandon Street and Clifton Grove
- From a point 14 metres east of its junction with Brandon Street and Clifton Grove to a point 21 metres west of its junction with Wrotham Road

BRANDON STREET On the eastern side.

- a) From a point 12 metres south of its junction with Darnley Street to a point 18 metres south of its junction with Darnley Street
- b) From the northern boundary of No 43 Brandon Street to the southern flank way of No 36 Brandon Street
- From a point 3 metres south of the northern flank wall of No 35 Brandon Street to the southern boundary of No 27 Brandon Street
- From the boundary of Nos 26/26a Brandon Street to a point 6 metres south of the boundary of Nos 26/26a Brandon Street
- e) From the boundary of Nos 25/26 Brandon Street to a point 15 metres north of its junction with Arthur Street

CAMBRIAN GROVE On the eastern side

a) From a point 15 metres north of its junction with Arthur

Street to a point in line with the northern boundary of No 12 Cambrian Grove.

 From a point 12 metres south of its junction with Spencer Street to a point 18 metres south of its junction with Spencer Street.

CLARENCE ROAD

On the northern side between a point 21 metres east of the junction with Windmill street and a point 10 metres east of the eastern boundary of 28 Clarence Row.

CLARENCE ROW

On the northern side between a point 21 metres east of the junction with Windmill Street and a point 10 metres east of the eastern boundary of 28 Clarence Row.

CLARENDON ROAD

i On the eastern side

- Between points 21 metres north of the junction with the Terrace and in line with the boundary of 8/9 Clarendon Road:
- Between points in line with the boundary of 10/11 Clarendon Road and the northern building line of 19 Clarendon Road.

ii On the western side

- a) Between points 21 metres north of the junction with the Terrace and in line with the boundary of 8/9 Clarendon Road, except across the frontage to 29 Clarendon Road;
- Between points in line with the boundary of 10/11 Clarendon Road and the northern building line of 19 Clarendon Road.

CLIFTON GROVE

On the western side

- a) From a point 12 metres south of its junction with Arthur Street to a point 8 metres south of the northern flank of Nos 9 to 17 Clifton Grove;
- From a point 3 metres south of the southern flank of Nos 9-17 Clifton Grove to a point 10 metres north of the northern flank of Nos 19 - 25 Clifton Grove (at right angles within turning head);
- c) From its southern extremity to a point 5 metres north of its southern extremity.

CUTMORE STREET

i On the western side

- a) From the boundary of Nos 2/3 Cutmore Street to the boundary of Nos 18/19 Cutmore Street;
- b) From the boundary of Nos 20/21 Cutmore Street to its northern extremity.

ii On the eastern side

- a) From a point 3 metres north of the southern flank of No 47 Cutmore Street to the boundary of Nos 44/45 Cutmore Street;
- b) From the boundary of Nos 34/40 Cutmore Street to the boundary of Nos 30/31 Cutmore Street;
- c) From its northern extremity to a point 15 metres south of its northern extremity.

DARNLEY ROAD i On the eastern side

- a) Between points 21 metres and 60 metres south of the junction with Darnley Street;
- b) Between points 66 metres and 86 metres south of the junction with Darnley Street;
- c) Between points 92 metres and 105 metres south of the junction with Darnley Street;
- d) Between points 19 metres and 25 metres north of the junction with Arthur Street;
- e) Between points 21 metres and 57 metres north of the junction with Trafalgar Road;
- f) Between points 26 metres and 37 metres south of the junction with Trafalgar Road;

ii On the western side

- a) Between points 21 metres and 57 metres south of the junction with Arthur Street and Arthur Street West;
- b) Between points 26 metres and 32 metres south of the junction with Trafalgar Road.

EAST TERRACE

On the eastern side between points 27 metres and 136 metres south of the junction with The Terrace.

GORDON PLACE

- a) On the northern side from a point in line with the eastern building line of 6 Gordon Place westwards to its western kerbline extremity;
- b) On the eastern side between points 29 metres and 66 metres north of the junction with East Terrace;
- c) On the southern side from its western kerbline extremity parallel to the northern flank wall of 3 Grodon Place to a point 7 metres east of that point;
- d) On the western side from its northern kerbline extremity across the frontage of 3a Gordon Place to a point 7 metres south of that point.

NINE ELMS GROVE On the eastern side

 a) From a point 12 metres south of its junction with Arthur Street to its southern extremity.

ROYAL PIER ROAD On the southern side

a) Between points 8 metres and 28 metres west of the north-western corner of Royal Pier Mews:

b) From a point in line with the western boundary of 1 Royal Pier Road to a point in line with the boundary of 12/13 Royal Pier Road (except across the access way between 4 and 5a Royal Pier Road.

SHEPPY PLACE On the western side

- a) From a point 10 metres south of its northern extremity for a distance of 77 metres in a southerly direction;
- b) From a point 15 metres north of its southern extremity for a distance of 17 metres in a northerly direction.

SPENCER STREET i On the southern side

- a) From a point 12 metres west of its junction with Cutmore Street to the boundary of Nos 16/17 Spencer Street.
- From a point 12 metres west of its junction with Cambrian Grove to the western boundary of No 21 Spencer Street.

ii On the northern side from its western extremity to a point 12 metres east of its western extremity.

TRAFALGAR ROAD On the southern side

- a) From a point 21 metres east of its junction with Darnley Road to a point 31 metres east of its junction with Darnley Road
- b) From a point 37 metres east of its junction with Darnley Road to a point 43 metres east of its junction with Darnley Road
- From a point 60 metres east of its junction with Darnley Road to a point 72 metres east of its junction with Darnley Road
- From a point 85 metres east of its junction with Darnley Road to a point 21 metres west of its junction with Wrotham Road
- (ii) The Second Schedule Part 3 Residents' Parking Places will continue to have effect with the deletion of all references to Brandon Street, Cutmore Street, Spencer Street and Trafalgar Street from the text.
