

THE BOROUGH OF GRAVESHAM
(PROHIBITION AND RESTRICTION OF WAITING) (CONSOLIDATION)
(AMENDMENT No. 4) ORDER 2007

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2) and 53 of the Road Traffic Regulation Act 1984, ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

A - The Borough of Gravesham (Prohibition and Restriction of Waiting) (Consolidation) Order 1992 shall have effect as though:

In the Schedule to the Order

LENNOX ROAD
GRAVESEND

The entry in the Schedule to be deleted and replaced with

LENNOX ROAD
GRAVESEND

No Waiting at Any-time

Both sides

- (i) Between its junction with Overcliffe and a point 21 metres south of that junction.
- (ii) Between its junction with Pelham Road and Lennox Road East and a point 21 metres north-west of that junction.

East side between points 21 metres north and 21 metres south of the junction with Lennox Avenue.

No waiting between the hours of 8 am - 6.30 pm
Monday to Saturday inclusive

'West Side'

Between a point 21 metres south of the junction with Overcliffe and a point 21 metres north-west of the junction with Pelham Road.

'East Side'

- (i) between a point 21 metres south of the Overcliffe and a point 21 metres north of the junction with Lennox Avenue.
- (ii) between points 21 metres and 43 metres south of the junction with Lennox Avenue.

- (iii) between a point 173 metres south of the junction with Lennox Avenue and 21 metres north west of the junction with Pelham Road.

ST JAMES'S ROAD,
GRAVESEND

The entry in the Schedule to be deleted and replaced with

ST JAMES'S ROAD,
GRAVESEND

No Waiting at Any-time

- (i) from the junction with Darnley to a point 21 metres west of that junction.
- (ii) from the junction with St James's Avenue to points opposite and in line with the eastern boundary of 49 St James's Road.

No waiting between the hours of 8 am - 6.30 pm

Monday to Saturday inclusive

'North Side'

- (i) between points 21 metres and 52 metres west of the junction with Darnley Road.
- (ii) between a point 108 metres west of the junction with St James's Street and a point opposite the eastern boundary of 49 St James's Road.

'South Side'

between a point 21 metres west of the junction with Darnley Road and a point in line with the eastern boundary of 49 St James's Road.

B. This Order may be cited as The Borough of Gravesham (Prohibition And Restriction of Waiting) (Consolidation) (Amendment No. 4) Order 2007 and shall come into operation on 14th day of January, 2008.
