The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2) and 53 of the Road Traffic Regulation Act 1984, ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

A - The Borough of Gravesham (Prohibition and Restriction of Waiting) (Consolidation) Order 1992 shall have effect as though -

In the Schedules to the Order -

HENHURST ROAD
GRAVESEND

The following shall be inserted in the Schedule in correct alphabetical sequence -

HENHURST ROAD
GRAVESEND

No waiting at any time

On both sides from and including the roundabout junction with the southern on and off slip roads from A2 trunk road to a point 84 metres south-eastwards thereof.

HEVER COURT ROAD
GRAVESEND

the entry in the Schedule to be deleted and replaced with

HEVER COURT ROAD
GRAVESEND

No waiting at any time

On both sides between a point 35 metres north-west of its junction with Sandown Road and the junction with Valley Drive.

LINK ROAD BETWEEN HEVER COURT ROAD AND HENHURST ROAD (MARLING CROSS OVERBRIDGE)
GRAVESEND

On both sides from and including the roundabout junction with the southern on and off slip roads from A2 trunk road to a point 84 metres south-eastwards thereof.

the entry in the Schedule to be deleted and replaced with

No waiting at any time

On both sides between a point 35 metres north-west of its junction with Sandown Road and the junction with Valley Drive.

LINK ROAD BETWEEN HEVER COURT ROAD AND HENHURST ROAD (MARLING CROSS OVERBRIDGE)

The following shall be inserted in the Schedule in correct alphabetical sequence -

No waiting at any time

On both sides between the roundabout junction with the northern off slip road from A2 trunk road and the roundabout junction with the southern on and off slip roads from A2 trunk road

VALLEY DRIVE

the entry in the Schedule to be deleted and replaced with

No waiting at any time

On both sides

- (i) from a point 42 metres north of the northern kerb line of the access road to Valley Drive lorry park (adjacent 424 Valley Drive) to and including the roundabout junction with Hever Court Road.
- (ii) between a point 21 metres north of its junction with Mackenzie Way and a point 21 metres south of that junction
- (iii) between its junction with Old Road West and a point 40 metres south of that junction
- (iv) between its junction with Hillside Avenue and its junction with Thomas Drive
- (v) between its junction with St Georges Crescent and a point 52 metres south-east of that junction

VALLEY DRIVE SERVICE ROAD

The following shall be inserted in the Schedule in correct alphabetical sequence -

VALLEY DRIVE (access road to lorry park adjacent 424 Valley Drive)
GRAVESEND

No waiting at any time

On both sides from the junction with Valley Drive westwards and southwards to the limit of the highway.

**WROTHAM ROAD (service road south-eastwards from Coldharbour Road Roundabout),
NORTHFLEET**

The following shall be inserted in the Schedule in correct alphabetical sequence -

**WROTHAM ROAD (service road south-eastwards from Coldharbour Road Roundabout),
NORTHFLEET**

No waiting at any time

On both sides from Coldharbour Road Roundabout to the south-eastern extremity of the highway except on the eastern side between a point in line with the southern boundary of 398 Wrotham Road and a point in line with the northern boundary of 418 Wrotham Road.


No waiting - Monday - Friday between 1pm and 1.30pm

On the eastern side from a point in line with the southern boundary of 398 Wrotham Road to a point in line with the northern boundary of 416 Wrotham Road.

No waiting at any time by goods vehicles having a maximum gross weight over 5 tonnes

On the eastern side from a point in line with the southern boundary of 398 Wrotham Road to a point in line with the northern boundary of 416 Wrotham Road.

B. This Order may be cited as The Borough of Gravesham (Prohibition And Restriction of Waiting) (Consolidation) (Amendment No. 6) Order 2009 and shall come into operation on 2nd February, 2009.
