THE KENT COUNTY COUNCIL (VARIOUS ROADS, MEOPHAM) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No. 2) ORDER 2007

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1) and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultations in accordance with Schedule 9 to the Act, hereby make the following Order:-

A - The Kent County Council (Various Roads, Meopham) (Waiting Restrictions and Street Parking Places) Order 2002 shall have effect as though -

In the Schedules of the Order:-

DENESWAY

The following to be added to the First Schedule in correct alphabetical sequence -

DENESWAY

On both sides from the junction with Wrotham Road for a distance of 15 metres in an easterly direction.

WROTHAM ROAD

The following to be inserted in the First Schedule in place of the existing entry -

WROTHAM ROAD

- (1) On both sides
- (a) from its junction with Green Lane to a point 113 metres south of its junction with Longfield Road;
- (b) from points opposite and in line with the southern building line of the property known as 'Firbank' northwards to points 21 metres north of The Street.
- (2) On the eastern side
- (a) between points 21 metres north and 21 metres south of the junction with Norwood Lane;
- (b) between points 21 metres north and 50 metres south of the junction with Pine Rise:
- (c) between points 15 metres south and 180 metres north of the junction with Denesway.
- (3) On the western side
- (a) between points 19 metres south-east and 17 metres north-west of its junction Johns Road;
- (b) from its junction with New Road for a distance of 18 metres in a southerly direction;
- (c) between a point 21 metres north of the junction with Cheshunt Close and a

point 50 metres south of the junction with Pine Rise;

- (d) between points 52 metres north and 6 metres south of the junction with Melliker Lane;
- (e) between points 28 metres and 150 metres south of the junction with Melliker Lane.

The following to be inserted in Part 1 of the Third Schedule in place of the existing entry -

WROTHAM ROAD


- (1) On the eastern side
- (a) between a point 21 metres south of its junction with Norwood Lane and a point 21 metres north of its junction Pine Rise;
- (b) between points 50 metres south of the junction with Pine Rise and 180 metres north of the junction with Denesway.
- (2) On the western side
- (a) between points 50 metres south of the junction with Pine Rise and 52 metres north of the junction with Melliker Lane;
- (b) between points 6 metres and 28 metres south of the junction with Melliker Lane,

B - This Order shall come into operation on the 17th December, 2007, and may be cited as The Kent County Council (Various Roads, Meopham) (Waiting Restrictions and Street Parking Places) (Amendment No. 2) Order 2007.

Proposed Amendment to Waiting Restrictions


