

**THE KENT COUNTY COUNCIL
(VARIOUS ROADS, GRAVESHAM) (WAITING RESTRICTIONS AND
STREET PARKING PLACES) (CONSOLIDATION) (AMENDMENT No 5) ORDER 2010**

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

In the Schedules to the Order

**ACCESS ROAD TO
VICARAGE LANE
AND MILLER ROAD**

The following item to be inserted in the First Schedule in the correct alphabetical sequence

ACCESS ROAD TO *On both sides from the junction with Rochester Avenue for a distance*
VICARAGE LANE *of 12 metres in a north easterly direction.*
AND MILLER ROAD

ARTHUR STREET

The following item to be inserted in the First Schedule in the correct alphabetical sequence

ARTHUR STREET (1) *On the northern side from a point 18 metres west to a point 18 metres east of the junction with Brandon Street;*
(2) *On the southern side from a point 16 metres west to a point 19 metres east of the junction with Clifton Grove.*

BRANDON STREET

The following item to be inserted in the First Schedule in the correct alphabetical sequence

BRANDON STREET *On both sides from the junction with Arthur Street for a distance of 12 metres in a northerly direction.*

CLIFTON GROVE

The following item to be inserted in the First Schedule in the correct alphabetical sequence

CLIFTON GROVE (1) *On the western side from the junction with Arthur Street for a distance of 18 metres in a southerly direction;*
(2) *on the eastern side from the junction with Arthur Street for a distance of 25 metres in a southerly direction (to the northern side of the access to the car park);*

ELMFIELD CLOSE

The existing item to be deleted in the First Schedule and replaced with the following

ELMFIELD CLOSE (1) *On the eastern side from the junction with Old West Road for a distance of 27 metres in a northerly direction;*
(2) *on the western side from the junction with Old West Road to the access to the garages in a northerly direction*

FORGE LANE

The following item to be inserted in the First Schedule in the correct alphabetical sequence

FORGE LANE *On both sides from the junction with Rochester Road for a distance of 12*

GROVE ROAD, NORTHFLEET

The following item to be inserted in the Second Schedule in the correct alphabetical sequence

GROVE ROAD, NORTHFLEET

On both sides from the junction with Galley Hill Road and Stonebridge Road for a distance of 270 metres in a north easterly direction.

OXFORD CLOSE

The following item to be inserted in the First Schedule in the correct alphabetical sequence

OXFORD CLOSE *On both sides from the junction with Rochester Road for a distance of 12 metres in a northerly direction.*

ROCHESTER ROAD

The following item to be inserted in the First Schedule in the correct alphabetical sequence

ROCHESTER ROAD *On the northern side*

- (i) *from a point in line with the common boundary of Nos 265 and 267 to a point in line with the common boundary of Nos 255 and 257 Rochester Road*
- (ii) *from a point in line with the common boundary of Nos 253 and 251 to a point in line with the common boundary of Nos 241 and 239 Rochester Road;*
- (iii) *from a point in line with eastern boundary of the Public House to a point in line with the common boundary of Nos 229 and 231 Rochester Road.*
- (vi) *from a point 20 metres east of the access road to the Public House to a point in line with the common boundary of Nos 191 and 193 Rochester Road.*

ROCHESTER ROAD

The existing item to be deleted in the Second Schedule and replaced with the following

ROCHESTER ROAD *On the southern side from a point 20 metres north west to a point 22 metres south east of the junction with Forge Lane.*

TERRENCE CLOSE

The following item to be inserted in the First Schedule in the correct alphabetical sequence

TERRENCE CLOSE *On both sides from the junction with Rochester Road for a distance of 12 metres in a northerly direction.*
