THE KENT COUNTY COUNCIL (PROHIBITION AND RESTRICTION OF WAITING) (VARIATION) ORDER 1996

THE KENT COUNTY COUNCIL in exercise of its powers under Sections 1 and 2 of the road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act hereby makes the following Order:-

- 1. This Order which comes into operation on 11th Nov. 1996 may be cited as the Kent County Council (Prohibition and Restiction of Waiting) (Variation) Order 1996.
- 2. The effect of the Order is to vary the provisions of the Borough of Gravesham (Prohibition and Restriction of Waiting) (Consolidation) Order 1992 (hereinafter "the 1992 Order") by introducing new restrictions on the waiting, loading or unloading of vehicles on the lengths of road set out in the Schedule below during school term time only between the hours of 8.00 am and 9.30 am and 2.30 pm and 4.00 pm Mondays to Fridays inclusive.
- 3. In this Order:-

"school term time" means those days of the year which have been determined as school days by the Kent County Council, the Education Authority, in accordance with Section 21 of the Education (No.2) Act 1986.

SCHEDULE

Additions to the 1992 Order
Lengths of roads in the Borough of Gravesham

Cimba Wood

(i) Between its junction with St. Francis Avenue and generally in a south westerly direction to the entrance

to the Riverview County Infants School.

(ii) Between its junction with Cimba Wood and a point 21m west of that junction; that is in front of properties numbered 25 and 52 Cimba Wood.

St. Francis Avenue

"North-east Side"

- (i) Between its junction with Way Volante and a point 21m south east of that junction;
- (ii) Between its junction with Way Volante and the south eastern extremity of the "school keep clear" marking;
- (iii) Between the north western extremity of the "school keep clear" marking and a point 16m to the north west;

"South-west Side"

- (i) Between its junction with Cimba Wood and a point 21m north west of that junction;
- (ii) Between its junction with Cimba Wood and a point 55m south east of that junction.

Way Volante

Between its junction with St. Francis Avenue and a point 21m north east of that junction;

Marling Way

"North Side"

Between the eastern extremity of the "school keep clear" marking and a point 18m east of that point.

"South Side"

- (i) Between its junction with Frobisher Way and a point 34m west of that junction;
- (ii) Between its junction with Frobisher Way and a point 21m east of that junction.

Frobisher Way

Between its junction with Marling Way and a point 21m south of that junction.
