**THE KENT COUNTY COUNCIL
(VARIOUS ROADS, GRAVESHAM) (PROHIBITION AND RESTRICTION OF WAITING)
(CONSOLIDATION) (AMENDMENT No 10) ORDER 2012**

Notice is hereby given that KENT COUNTY COUNCIL propose to make the above named Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), and 124 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act:

The effect of the Order will be to:

1. Introduce no waiting at any time (double yellow lines) restrictions on the following roads or lengths of road in Gravesham:

Gravesend Road, Higham (A226)	Forge Lane, Higham	Crutches Lane, Higham
----------------------------------	--------------------	-----------------------

2. Introduce no loading at any time restrictions on the following roads or lengths of road in Gravesham:

Gravesend Road, Higham (A226)

3. Introduce no waiting between 8am-9.30am or 2.30pm-4pm, Mon-Fri inclusive (single yellow lines) on the following roads or lengths of road in Gravesham:

Crutches Lane, Higham

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

A - The Borough of Gravesham (Prohibition and Restriction of Waiting) (Consolidation) Order 1992 shall have effect as set out in the Schedule to this Order

First Schedule

**Additions to the Schedule to The Borough of Gravesham (Prohibition and
Restriction of Waiting) (Consolidation) Order 1992**

The following items to be added to the Schedule in the correct alphabetical sequence

GRAVESEND ROAD (A226), HIGHAM

No Waiting at any time

On both sides from the junction with Telegraph Hill in a north westerly direction to a point 65 metres west of the junction with Crutches Lane

No Loading at any time

- i) On the north west side from a point 31 metres north west of the junction with Telegraph Hill in a north westerly direction to a point 65 metres west of the junction with Crutches Lane*
- ii) On the south east side from the junction with Telegraph Hill in a north westerly direction to a point 65 metres west of the junction with Crutches Lane*

FORGE LANE, HIGHAM

No Waiting at any time

On both sides from the junction with Gravesend Road (A226) in a northerly direction to a point in line with the northern common boundary of house numbers 57 and 55.

CRUTCHES LANE, HIGHAM

No Waiting at any time

(1) On the south eastern side from its junction with Gravesend Road (A226) to a point 21 metres south west of that junction

(2) On the north western side from the junction with Gravesend Road (A226) to a point in line with the northern boundary of house number 1.

No Waiting between the hours of 8am - 9.30am and 2.30pm - 4pm, Monday to Friday inclusive

On the south eastern side from a point 21 metres south west of the junction with Gravesend Road (A226) to a point in line with the common boundary of house numbers 2 and 3.

This Order shall come into operation on the 12th day of November 2012 and may be cited as The Kent County Council (Various Roads, Gravesham) (Waiting Restrictions and Street Parking Places) (Consolidation) (Amendment No 10) Order 2012.
