ROAD TRAFFIC REGULATION ORDER ACT 1984

The KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order:-

Revocations

Part 1: Schedule of Revocations

The following Items to be revoked from the following order:

**THE BOROUGH OF GRAVESHAM (PROHIBITION AND RESTRICTION OF WAITING)
(CONSOLIDATION) ORDER 1992**

**DARNLEY ROAD
GRAVESEND**

No Waiting at any time

(ii) Between a point 21m north of its junction with Arthur Street and a point 21m south of that junction.

No Waiting between the hours of 8 am – 6.30pm Monday to Saturday inclusive

"West Side"

(i) Between a point 21m south of its junction with Darnley Street and a point 21m north of its junction with Arthur Street West.

(ii) Between a point 57m south of its junction with Arthur Street West and a point 21m south of its junction with Trafalgar Road.

"East Side"

Between a point 21m south of its junction with Arthur Street and a point 57m north of its junction with Trafalgar Road.

Part 2: Schedule of Items to be Inserted

"West Side"

Between a point 43 metres north of its junction with Arthur Street West and a point 43 metres south of that junction.

"East Side"

Between a point 21 metres north of its junction with Arthur Street and a point 43 metres south of that junction.

No Waiting between the hours of 8 am – 6.30pm Monday to Saturday inclusive

"West Side"

- (i) Between a point 21 metres south of its junction with Darnley Street and a point 43 metres north of its junction with Arthur Street West.
- (ii) Between a point 43 metres south of its junction with Arthur Street West and a point 21 metres south of its junction with Trafalgar Road.
