THE KENT COUNTY COUNCIL (VARIOUS ROADS, NORTHFLEET) (STREET PARKING PLACES) ORDER 2011

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and 53 of the Road Traffic Regulation Act 1984, ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

A – the Kent County Council (Various Roads, Gravesend) (Street Parking Places) Order 2005 and its subsequent amendments shall have effect as though .

1. The following entry be added to Part 1 of the Second Schedule (Zones for Residents' Permits) in the correct alphanumeric position.

Zone: Northfleet (Fountain Walk Area) **Zone Code**: F

Residents having an address described in this column	May purchase a Residents' Parking Permit to park without limit of time in a designated residents' parking bay in any of these roads.
Beresford Road	Beresford Road
Fountain Walk	Fountain Walk
London Road (even nos from 58 to 72	London Road
only)	

2. The entry in Part 4 of the Second Schedule to be deleted and replaced with the following:

THE HILL, NORTHFLEET

At an angle to the kerb on the southern side of the service road fronting 7 – 12 The Hill between points 1 metres and 29 metres east of the western building line of 12 The Hill.

BERESFORD ROAD, NORTHFLEET

Along the west side (fronting Nos 1 to 59) from a point 21 metres south of its junction with London Road in a southerly direction for a distance of 175 metres.

FOUNTAIN WALK, NORTHFLEET

- Along the west side (fronting Nos 22 to 33) from a point 15 metres north of its junction with London Road in a northerly direction for a distance of 35 metres.
- ii. Along the south eastern side of from a point 5 metres north east of a point in line with the kerbline extended fronting Nos 43 to 57 Fountain Walk in a north easterly direction for a distance of 18 metres.
- iii. Along the south eastern side from a point 10 metres south west of a point in line with the kerbline extended fronting Nos 82 to 88 Fountain Walk in a south westerly direction for a distance of 100 metres.
- iv. Along both sides from a point 5 metres west of a point in line with the kerbline extended fronting Nos 22 to 33 Fountain Walk in a westerly direction for a distance of 20 metres.

LONDON ROAD, NORTHFLEET

Along the south side (fronting Nos 62 to 72) from a point 45 metres east of its junction with Beresford Road in an easterly direction to a point in line with the common boundary of Nos 72 and 73 London Road.

B – the Kent County Council (Various Road, Northfleet)(Waiting Restrictions and Street Parking Places) Order 2007 and its subsquent amendments has effect as though:

1. In the First Schedule (No Waiting at any time) under references to Beresford Road and Fountain Walk be deleted and replaced with the following in the correct alphanumeric position.

BERESFORD ROAD, NORTHFLEET

- i. Along both sides from its junction with London Road in a southerly direction for a distance of 21 metres.
- ii. Along the east side from a point 90 metres south of its junction with London Road in a southerly direction for a distance of 16 metres.
- iii. Along the east side from a point 127 metres south of its junction with London Road in a southerly direction for a distance of 12 metres.
- iv. Along the east side from a point 8 metres north of its junction with Collington Close to a point 8 metres south of the same junction.
- v. Along the east side from its junction with St Marks Avenue in a northerly direction for a distance of 8 metres.

COLLINGTON CLOSE, NORTHFLEET

Along both sides from its junction with Beresford Road in an easterly direction for a distance of 10 metres in an easterly direction.

FOUNTAIN WALK, NORTHFLEET

Along both sides from its junction with London Road in a northerly direction for a distance of 15 metres.

- Along the south eastern side from a point 23 metres north east of a
 point in line with the kerbline extended fronting Nos 43 to 57 Fountain
 Walk in a north easterly direction for a distance of 20 metres. Existing
 disabled parking bays to be retained.
- ii. Along the south eastern side from a point 10 metres south west of a point in line with the kerbline extended fronting Nos 82 to 88 Fountain Walk in an easterly and southerly direction to a point in line with the common boundary of Nos 82 and 83 Fountain Walk.
- iii. Along the south eastern side from a point in line with the common boundary of Nos 95 and 95 Fountain Walk in a northerly and easterly direction to the end of that road.
- iv. Along the north western side from a point in line with the kerbline extended fronting Nos 22 to 33 Fountain Walk in a north easterly direction for the remainder of its length.

ST MARK'S AVENUE, NORTHFLEET

Along the north side from its junction with Beresford Road in an easterly direction for a distance of 10 metres.

2. In the Second Schedule (Daytime Waiting Restrictions) references to Fountain Walk be deleted and the following wording added in correct alphanumeric position.

FOUNTAIN WALK, NORTHFLEET (No Waiting between 8am and 6.30pm Mon to Sat)

Along the east side fronting Nos 43 to 57 from a point 15 metres north of its junction with London Road in a northerly direction for a distance of 45 metres.

LONDON ROAD, NORTHFLEET (No Waiting between 8 am and 6.30pm Mon to Sat)

Along the north side from a point 21 metres east of its junction with Fountain Walk in an easterly direction for a distance of 90 metres.

C. This Order may be cited as the Kent County Council (Various Roads, Northfleet) (Street Parking Places) Order 2011 and shall come into operation on 31st May 2011.
