

**THE KENT COUNTY COUNCIL  
(VARIOUS ROADS, GRAVESEND) (WAITING RESTRICTIONS AND  
STREET PARKING PLACES) (AMENDMENT No 1) ORDER 2009**

The Council of the County of Kent in exercise of their powers under sections 1(1), 2() to (3), 3(2), 4(1) and (2), 32(1) and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultations in accordance with Schedule 9 to the Act, has made the above Order

**A** – This Order may be cited as the Kent County Council (Various Roads, Gravesend) (Waiting Restrictions and Street Parking Places) (Amendment No 1) Order 2009 and will come into force on the 24 February 2010.

**B** – The Kent County Council (Various Roads, Gravesend) (Waiting Restrictions and Street Parking Places) (Amendment No 1) Order 2009, the previous Order The Kent County Council (Various Roads, Gravesend) (Waiting Restrictions and Street Parking Places) Order 2009 shall have effect as though:-

**In the Articles of the Order of the first schedule Part two shall have inserted:-**

**Zone Three**

William Street	(i) On its northern side from a point 21 metres west of its junction with Parrock Street to a point 10 metres east of its junction with Peter Street.  (ii) On its southern side from a point 10 metres west of its junction with Peter Street to its western extremity.

**In the Articles of the Order of the first schedule Part three shall have inserted:-**

**Zone Five**

Lennox Road East	(i) On its northern side from a point 21 metres east of its junction with Pelham Road in an easterly direction to a point 21 metres west of its junction with Darnley Road.  (ii) On its southern side from a point in line with the western boundary of No 2 Lennox Road East in an easterly direction to a point 21 metres west of its junction with Darnley Road.

This Order hereby revokes all previous Waiting Restriction and Parking Place Orders which refer to the lengths of William Street and Lennox Road East specified above.

**IN THE Articles of the Order of the Second Schedule zone three and zone four should be replaced as follows:-**



Zone Four	Elmfield Close Essex Road Kent Road Lynton Road Old Road West from its junction with Darnley Road to its junction with Singlewell Road Portland Road Weavers Close Windmill Street (between its junction with Leith Park Road and South Street) Wrotham Road (between its junctions with Old Road West and Trafalgar Road)
