# THE KENT COUNTY COUNCIL (VARIOUS ROADS, GRAVESEND) (TOWN CENTRE PEDESTRIANISATION RESTRICTIONS) (AMENDMENT) ORDER 1997

THE KENT COUNTY COUNCIL in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

- This Order may be cited as The Kent County Council (Various Roads, Gravesend) (Town Centre Pedestrianisation Restrictions) (Amendment) Order 1997 and shall come into force on 1st September 1997
- 2. The Kent County Council (Various Roads, Gravesend) (Town Centre Pedestrianisation Restrictions) Order 1996 (hereinafter 'the 1996 Order') is hereby amended as follows:-

Articles 5 and 6 of and Schedule 2 to the 1996 Order shall be deleted and the following Articles and Schedule shall be inserted in substitution thereof:-

- 5. Nothing in Article 3 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along any of the lengths of road specified in Schedule 2 to this Order:-
  - (a) As regards the lengths of roads specified in Schedule 2 Part I if the vehicle is being used for access or conveyance of goods to or from any premises situated in or adjacent to either King Street or that length of New Road from its junction with High Street and Windmill Street and its junction with Darnley Road and Bath Street between

the hours of 6.00 p.m. and 10.00 a.m. on  $\underline{\text{all}}$  days.

- (b) As regards the length of road specified in Schedule 2 Part II if the vehicle is being used for access or conveyance of goods to or from any premises situated in or adjacent to Manor Road between the hours of 10.30 a.m. and 4.30 p.m. on all days.
- 6. Nothing in Article 3 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along any lengths of road specified in Schedule 3 to this Order.
  - (a) if the vehicle is a goods vehicle as defined by Section 192 of the Road Traffic Act 1988 and is being used for the conveyance of goods to or from premises situated in any of the lengths of road between the hours of 6.00 pm and 10.00 am on all days.
