THE NORFOLK COUNTY COUNCIL (GREAT YARMOUTH, TRAFALGAR ROAD) (PROHIBITION OF WAITING, LOADING AND UNLOADING) AMENDMENT ORDER 2018

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. <u>Citation and Commencement</u>

This Order may be cited as the "The Norfolk County Council (Great Yarmouth, Trafalgar Road) (Prohibition of Waiting, Loading and Unloading) Amendment Order 2018 and shall come into effect for all purposes on the 8th day of January 2018.

- 2. The Norfolk County Council (Great Yarmouth, Residents Parking Area) (Prohibition of Waiting) Order 2014 (hereinafter referred to as the "2014 Order") is amended as set out in Articles 3 and 4 of this Order.
- 3. Schedule 1 of the 2014 Order is amended by the addition of the length of Trafalgar Road as set out in Schedule 1 of this Order.
- 4. The following paragraph is inserted as Article 3(A) to the 2014 Order:
 - "3(A) No person shall, except upon the direction of, or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait, load or unload along the lengths of road specified in Schedule 4 of this Order at any time."
- 5. No person shall, except upon the direction of, or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait, load or unload along the lengths of road specified in Schedule 2 of this Order at any time.
- 6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
