

**THE BOROUGH OF GREAT YARMOUTH**  
**(OFF-STREET PARKING PLACES) (LORRY AND COACH PARKING PLACES) AND**  
**(RESIDENTIAL PARKING PLACES ) CIVIL ENFORCEMENT (No 2) ORDER 2014**

The Borough of Great Yarmouth, in exercise of their powers under sections 32, 35, 38, and 39 of the Road Traffic Regulation Act, 1984 ("the 1984 Act"), Part 6 of the Traffic Management Act 2004 ("the 2004 Act") and with the consent of Norfolk County Council and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Parts I to III of Schedule 9 to the 1984 Act, hereby make the following Order.

**PART I**  
**GENERAL**

**Commencement and Citation**

1. This Order shall come into operation on the 14<sup>th</sup> day of November 2014, and may be cited as The Borough of Great Yarmouth (Off-Street Parking Places) (Lorry and Coach Parking Places) and (Residential Parking Places) Civil Enforcement (No 2) Order 2014.

**Interpretation**

**2.(1) In this Order:-**

"Agent" for issue of Special Olympian Parking Tickets for Parking Places 13 and 14 Marina Centre South and Marina Centre North shall be the Marina Centre;

"Bus" has the same meaning as in Regulation 22(2) of the Traffic Signs Regulations and General Directions 2002"

"Charging Hours" means the periods specified in Column 4 of Schedules 1 to 6 to this Order in respect of which a charge is made as specified in Article 3;

"Civil Enforcement Officer" has the same meaning as in section 76 of the 2004 Act;

"Coach" means a Private Service Vehicle being used as part of an excursion or tour;

"Council" means Great Yarmouth Borough Council;

"Driver" in relation to a vehicle waiting in a Parking Place, means the person driving the vehicle at the time it was left in the Parking Place;

"Disabled Parking Bay" means an area of the Parking Place indicated as such as an area where a vehicle displaying a Disabled Person's Badge in accordance with the provisions of this Order may be stationed;

"Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000; and

"Parking Disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No 3551:

1970), but coloured blue and capable of showing the quarter hours period during which a period of waiting begins; and

for the purposes of this Order a vehicle shall be regarded as displaying a Disabled Person's Badge in the relevant position, when

- (a)(i) in the case of a vehicle fitted with a front windscreen the badge is exhibited facing forwards of the near side of and immediately behind the windscreen, or
- (ii) in the case of a vehicle not fitted with a front windscreen the badge is exhibited in a conspicuous position on the side of the vehicle, and
- (b) the parking disc is exhibited in the relevant position with the side which shows the time facing forwards or outwards.

"Disabled Person's Vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000"

"Enforcement Authority" means the Council;

"Excursion or Tour" has the same meaning as in s137(1) of the Transport Act 1985(a);

"General Regulations 2007" means The Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"Heavy Commercial Vehicle" has the same meaning as in section 138 of the 1984 Act;

"Lorry" means a motor vehicle constructed or adapted for use for the carriage of goods or burden of any description, or a trailer so constructed or adapted and includes a Heavy Commercial Vehicle;

"Lorry and Coach Parking Place" means a Parking Place specified in the Schedules to this Order as a parking place available for Lorry and Coach parking;

"Marina Centre Day Permit" means a Parking Ticket issued by the Council or its Agent for authorised personnel undertaking work at the Marina Centre;

"Motor Car", "Motor Cycle" and "Invalid Carriage" shall have the same meaning as in section 136 of the 1984 Act;

"Motor Cycle Parking Area" means an area of the Parking Place indicated as such as an area where a Motor Cycle, in accordance with the provisions of this Order, may be stationed;

"Parking Bay" means an area of the Parking Place indicated by markings on the surface of the Parking Place as an area where a vehicle, in accordance with the provisions of this Order, may be stationed;

"Parking Charge" means the sum of money specified in Column 5 of the Schedules to this Order;

"Penalty Charge" has the same meaning as in section 2 of the General Regulations 2007;

"Penalty Charge Notice" has the same meaning as in section 8 of the General Regulations 2007;

"Parking Place" means the area of land specified by name in Column 1 of the Schedules to this Order provided by the Council for use as a parking place;

"Private Service Vehicle" means a bus being used as part of an excursion or tour;

"Public Service Vehicle" has the same meaning as in section 1 of the Public Passenger Vehicles Act 1981;

"Residential Parking ticket" means a badge issued by the Council authorising a specified vehicle to be parked within a specified Residential Parking Bay in a specified Residential Parking Place in accordance with Article 9 of this Order;

"Residential Parking Bay" means any part of a Residential Parking Place that is indicated by markings on the surface of the Parking Place or otherwise as an area where a single vehicle, in accordance with the provisions of this Order, may be stationed;

"Residential Parking Place" means a Parking Place specified in Schedule 5 to this Order and provided by the Council for residential parking in accordance with Article 9 of this Order;

"Special Olympian Parking Ticket" shall mean a Parking Ticket as specified in Schedule 7 of this Order for use in accordance with Article 7 at Parking Places 13 and 14 of this Order;

"Ticket Machine" means an apparatus of a type and design approved by the Secretary of State for the purpose of this Order, being an apparatus designed to issue parking tickets indicating the payment of a Parking Charge and the date and time at which the charge was paid;

- 2.(2) Except where the context requires otherwise, any reference in this Order to a numbered Article shall be construed as a reference to the Article bearing that number in this Order;
- 2.(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment. Unless the context otherwise requires words denoting the singular shall include the plural and vice versa and words denoting persons shall include either gender, bodies corporate, unincorporated associations and partnerships.

## **PART II**

### **DESIGNATION, USE AND CHARGES FOR PARKING PLACES**

#### **Designation**

3. Each Parking Place, may be used, subject to the provisions of this Order, as a parking place for the classes of vehicles to be stationed in the appropriate Parking Bays on the days and during the hours, and on payment of such charges as are specified in relation to the Parking Place in the Schedules to this Order.

#### **Class and position of vehicles**

4. Where in the Schedules to this Order the Parking Place, is described, or where a Parking Bay or Residential Parking Bay is designated by surface or other markings, as available for vehicles of a specified class, the driver of a vehicle shall not permit it to wait in the Parking Place, or Parking Bay unless it is of the specified class.
5. Subject to the Parking Place having marked Parking Bays, no vehicles shall be left in the Parking Place other than wholly within a Parking Bay and in particular no vehicle shall be left or allowed to stand in the Parking Place in such a position as to obstruct:-
  - (i) the entrance or exit of the Parking Place, nor
  - (ii) the waste receptacles within the Parking Place, nor
  - (iii) the driving away of any vehicle already standing in the Parking Place or other vehicles generally.

#### **Payment**

- 6(1)(a) The Driver of a vehicle using a Pay and Display Parking Place, shall, on leaving the vehicle wholly within a Parking Bay (where marked in the Parking Place) and prior to leaving the Parking Place pay the appropriate Parking Charge in accordance with the scale of charges specified in Column 5 of the Schedules to this Order.
- 6(1)(b) The rider of a motor cycle using a Parking Place:-
  - (i) which contains a designated motor cycle parking area may park that motor cycle wholly within that designated motor cycle parking area of the Parking Place without payment of the Parking Charge;
  - (ii) must, if parked within any other parking bay within a Parking Place, pay the appropriate parking charge as specified in Article 6(1) (a) of this Order.
- 6(2) The Parking Charge referred to in Article 6(1) above will be payable by:-
  - (i) the insertion of an appropriate coin or coins into a ticket Machine. The Driver having paid the Parking Charge will be issued with a ticket via the ticket machine: or
  - (ii) other means as authorised by the Council and prominently displayed on a board at the Parking Place;
  - (iii) the purchase of a ticket from an officer or agent of the Council or by agreed payment account established with the Council at the Lorry and Coach Parking Place (Parking Place No 20).



- 6(3). The Driver of a vehicle using a Pay and Display Parking Place in accordance with Articles 6(1) and 6(2) of this Order and:-
- (i) which vehicle possesses a windscreen shall display the ticket issued by a ticket machine within the vehicle by attaching it firmly to the front windscreen or by placing it on the dashboard of the vehicle;
  - (ii) which vehicle does not possess a windscreen shall display the ticket issued by a ticket machine in a conspicuous position,
- so that payment in accordance with the scale of charges appropriate to the Parking Place as specified in the Schedules to this Order, the day, date and time of issue and all other particulars shown are clearly visible from outside the vehicle during the entire period the vehicle is waiting in the Parking Place. A ticket which is not displayed in accordance with this clause is not valid.
- 6(4) Any ticket issued on payment of the Parking Charge referred to in Articles 6(1) and 6(2) of this Order is not transferable and shall not be valid for any vehicle (whether or not that other vehicle is owned or is under the control of the Driver) other than that for which it was originally purchased by the Driver.
- 6(5) No payment is required by a vehicle parking in Parking Place 13 or 14 and displaying a Marina Centre Day Permit provided that Permit is valid and displayed in accordance with Articles 6(3) and 6(4) of this Order.

#### **Special Olympian Parking Ticket for Parking Places 13 and 14**

- 7(1) The Driver of a vehicle who is member of the Special Olympians may subject to the Council's discretion and on application to the Council or its Agent purchase a Special Olympian Parking Ticket in respect of that vehicle to wait on Sunday between 11.30 a.m. and 4.30 p.m. in Parking Places 13 or 14 subject to the purchase of an additional £1.00 Pay and Display Ticket.
- 7(2) A Special Olympian Parking Ticket issued by the Council or its Agent will be valid for a period of twelve months.
- 7(3) A Special Olympian Parking Ticket issued by the Council or its Agent must be displayed in accordance with Article 7(4) of this Order.
- 7(4). The Driver of a vehicle using a Parking Place in accordance with Articles 7(1) and 7(3) of this Order and:-
- (i) which vehicle possesses a windscreen shall display the Special Olympian Parking Ticket and the Pay and Display ticket within the vehicle by attaching both firmly to the front windscreen or by placing it on the dashboard of the vehicle;
  - (ii) which vehicle does not possess a windscreen shall display both Special Olympian Parking Ticket and Pay and Display ticket in a conspicuous position,
- so that both Parking Tickets are clearly visible from outside the vehicle during the entire period the vehicle is waiting in the Parking Place. A Special Olympian Parking Ticket and Pay and Display ticket not displayed in accordance with this clause is not valid.

- 7(5) Any Special Olympian Parking ticket issued to the driver of a specified vehicle in accordance with Article 7(1) of this Order shall not be valid on any vehicle other than that vehicle for which it was originally purchased by the driver (whether or not that other vehicle is owned or is under the control of the driver).
- 7(6) The Driver of a vehicle to which a Special Olympian Parking Ticket has been issued shall abide by the Council's specified terms and conditions for use of that Ticket.
- 7(7) Any Special Olympian Parking Ticket issued to the driver of a vehicle using Parking Places 13 and 14 remains the property of the Council and must be surrendered upon request.
- 7(8) Damaged or lost Special Olympian Parking Tickets will be replaced by the Council free of charge. The damaged or lost Ticket will then become immediately invalid.
- 7(9) The holder of a Special Olympian Parking Ticket shall on surrendering that ticket to the Council be entitled to a refund of money proportionate to the unexpired period of that ticket in accordance with the Council's terms and conditions for holding a Parking Ticket. The Council may transfer the unexpired period of the surrendered Parking Ticket to a new vehicle by issue of a new Special Olympian Residential Parking Ticket in lieu of a refund of monies subject to the relevant administration fee and procedure stated in the Council's terms and conditions of holding that Ticket.
- 7(10) If, in the reasonable opinion of the Council, the holder of a Special Olympian Parking Ticket uses that Ticket in such a way as to cause a nuisance to other users of Parking Places 13 or 14 or to the owners or occupiers of adjoining property, the Council or its Agent may by way of notice in writing to the holder of the Ticket cancel the Special Olympian Parking Ticket.

### **Season Tickets**

- 8(1). The Driver of a vehicle may subject to the Council's discretion and on application to the Council purchase a season ticket for a vehicle to wait in a Parking Place (where season tickets are available for use in that Parking Place as specified in Schedule 7 of this Order), in respect of that vehicle. A season ticket issued by the Council in accordance with this Article will specify the vehicle permitted by the driver to wait in a Parking Bay and also the Parking Place(s) to which the season ticket applies. The driver of the vehicle specified on the season ticket may use a Parking Place to which that season ticket applies without payment of the Parking Charge specified in Articles 6(1) and 6(2) of this order and Column 5 of Schedules 1 to 6 of this Order provided the season ticket is valid and is displayed in accordance with Article 8(2) of this Order.
- 8(2). The Driver of a vehicle using a Parking Place in accordance with Article 8(1) of this Order and:-
- (i) which vehicle possesses a windscreen shall display the ticket within the vehicle by attaching it firmly to the front windscreen or by placing it on the dashboard of the vehicle;
  - (ii) which vehicle does not possess a windscreen shall display the ticket in a conspicuous position,

so that the season ticket is clearly visible from outside the vehicle during the entire period the vehicle is waiting in the Parking Place. A ticket which is not displayed in accordance with this clause is not valid.

- 8(3) Any season ticket issued to the driver of a specified vehicle in accordance with Article 8(1) of this Order shall not be valid on any vehicle other than that vehicle for which it was originally purchased by the driver (whether or not that other vehicle is owned or is under the control of the driver).
- 8(4) The Driver of a vehicle to which a season ticket has been issued shall abide by the Council's terms and conditions for use of that season ticket.
- 8(5) Any season ticket issued to the driver of a vehicle using a Parking Place remains the property of the Council and must be surrendered upon request.
- 8(6) Damaged or lost season tickets will be replaced by the Council free of charge. The damaged or lost season ticket will then become immediately invalid.
- 8(7) The holder of a season ticket shall on surrendering their season ticket to the Council be entitled to a refund of money proportionate to the number of complete months remaining un-expired from the beginning of the calendar month following the date upon which the Council receives the surrendered season ticket. The Council may transfer the unexpired period of the surrendered season ticket to a new vehicle by issue of a new season ticket in lieu of a refund of monies subject to the relevant administration fee and procedure stated in the Council's terms and conditions of holding such a ticket.

### **Residential Parking**

- 9(1) The Driver of a vehicle may subject to the Council's discretion and on application to the Council purchase a Residential Parking Ticket in respect of that vehicle to wait in a Parking Place. A Residential Parking Ticket issued by the Council will be valid for the period stated on that Ticket. A Residential Parking Ticket issued by the Council may be used to allow a vehicle to wait in a Residential Parking Bay in a Residential Parking Place (as specified in Schedules 5 and 7 of this Order) without payment of the Parking Charge specified in Articles 6(1) and 6(2) of this Order provided the Residential Parking Ticket is valid for that Parking Place and is displayed in accordance with Article 9(2) of this Order.
- 9(2). The Driver of a vehicle using a Parking Place in accordance with Article 9(1) of this Order and:-
  - (iii) which vehicle possesses a windscreen shall display the ticket within the vehicle by attaching it firmly to the front windscreen or by placing it on the dashboard of the vehicle;
  - (iv) which vehicle does not possess a windscreen shall display the ticket in a conspicuous position,so that the Residential Parking ticket is clearly visible from outside the vehicle during the entire period the vehicle is waiting in the Parking Place. A ticket which is not displayed in accordance with this clause is not valid.

- 9(3) Any Residential Parking ticket issued to the driver of a specified vehicle in accordance with Article 9(1) of this Order shall not be valid on any vehicle other than that vehicle for which it was originally purchased by the driver (whether or not that other vehicle is owned or is under the control of the driver).
- 9(4) The Driver of a vehicle to which a Residential Parking ticket has been issued shall abide by the Council's specified terms and conditions for use of that Residential Parking ticket.
- 9(5) Any Residential Parking ticket issued to the driver of a vehicle using a Residential Parking Place remains the property of the Council and must be surrendered upon request.
- 9(6) Damaged or lost Residential Parking tickets will be replaced by the Council free of charge. The damaged or lost Residential Parking ticket will then become immediately invalid.
- 9(7) The holder of a Residential Parking ticket shall on surrendering that ticket to the Council be entitled to a refund of money proportionate to the unexpired period of that ticket in accordance with the Council's terms and conditions for holding a Residential Parking ticket. The Council may transfer the unexpired period of the surrendered Residential Parking ticket to a new vehicle by issue of a new Residential Parking ticket in lieu of a refund of monies subject to the relevant administration fee and procedure stated in the Council's terms and conditions of holding such a ticket.
- 9(8) If, in the reasonable opinion of the Council, the holder of a Residential Parking ticket uses a Residential Parking Place in such a way as to cause a nuisance to other users of the Residential Parking Place or to the owners or occupiers of adjoining property, the Council may by way of notice in writing to the holder of the Residential Parking ticket cancel the Residential Parking ticket.

### **Disabled Person's Parking**

10. The Driver of a vehicle displaying a Disabled Persons Badge may (subject to compliance with all other provisions of this Order) park that vehicle in a Disabled Parking Bay provided that:
- (a) the Driver of the vehicle is a disabled person to whom the badge was issued in respect of that vehicle,
  - (b) the vehicle is being used for the carriage of a disabled person to whom the badge was issued,
  - (c) the vehicle is one being used for the carriage of disabled persons by an institution to whom the badge was issued in respect of that vehicle; or
  - (d) the time during which the vehicle will be parked in the said parking bay is indicated on the parking disc provided by the local authority for that purpose.

## **Restrictions on use**

11. The Driver of a vehicle using the Parking Place, shall stop the engine as soon as the vehicle has been parked and shall not start the engine except when about to change the position of the vehicle in the Parking Place or to depart from the Parking Place.
12. Except with the authority in writing of the Council or person authorised on behalf of the Council, no person shall use a vehicle, whilst it is in the Parking Place, in connection with the sale of any article to persons in or near the Parking Place, or in connection with the selling or offering for hire of his skill or services.
13. Except with the authority in writing of the Council or person authorised on behalf of the Council, no person shall affix or cause to be affixed any advertising material to any vehicle left in the Parking Place.
14. The driver of a motor vehicle using the Parking Place, shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the Parking Place.
15. No person shall, except with the permission of any person duly authorised by the Council or a Civil Enforcement Officer, drive any vehicle in the Parking Place, other than for the purpose of parking that vehicle in the Parking Place, in accordance with the provisions of this Order or for the purpose of departing from the Parking Place.
16. No person shall, in the Parking Place, wantonly shout or otherwise make a loud noise to the disturbance or annoyance of users of the Parking Place, or residents of premises in the neighbourhood.
17. No person shall in the Parking Place, use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.
18. The Driver of a Coach who has purchased a day ticket or bay ticket (as opposed to a weekly ticket) must not pick up passengers from the Lorry and Coach Parking Place after 11.30pm.
19. The Driver of a Lorry containing a refrigeration unit using the Lorry and Coach Parking Place (Parking Place No 20) shall not operate the refrigeration unit between the hours of 8.00pm and 7.00am.
20. No person shall use any part of the Parking Place, or any vehicle left in the Parking Place:
  - (a) for sleeping or camping purposes;
  - (b) for eating or cooking purposes;
  - (c) for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the Parking Place;
  - (d) for skateboarding, roller skating or wheeled activities which may be hazardous to pedestrians;

(e) for the instruction of pupils whilst undertaking driving lessons,

provided the Driver of a Lorry using the Lorry and Coach Parking Place may sleep and eat in his cab, but not cook there.

21. No person shall play or take part in any game in the Parking Place.
22. No person shall use the Parking Place, as a means of passing or proceeding from one road to another road.
23. Where in the Parking Place, signs are erected or surface markings are laid for the purpose of:

- (a) indicating the entrance to or exit from the Parking Place; or
- (b) indicating that a vehicle using the Parking Place, shall proceed in a specified direction within the Parking Place;

no person shall drive or cause or permit to be driven any vehicle so that it

- (i) enters the Parking Place otherwise than by an entrance or leaves the Parking Place otherwise than by an exit so indicated or
- (ii) that it proceeds otherwise than in a specified direction.

24. In the Parking Place, no person shall:

- (a) erect or cause or permit to be erected any tent, booth, stand, building or other structure except with the authority of the Council or person authorised on behalf of the Council; or
- (b) light or cause or permit to be lit any fire.

25. No person shall proceed to enter the Parking Place whilst towing any vehicle except:

- (i) where the towed vehicle is required in order that a vehicle may be removed in accordance with the provision of this Order;
- (ii) where the towed vehicle is carrying equipment required by the driver for ground maintenance at the Parking Place;
- (iii) where the towed vehicle is required for remedial works at or to the Parking Place by statutory utilities staff;
- (iv) where permission has been granted by the Council or an agent acting on behalf of the Council or a Civil Enforcement Officer.

26. In the Parking Place no person shall leave a vehicle stationed overnight, except upon the direction or with the permission of the Council or an agent acting on behalf the Council or a Civil Enforcement Officer. This Article shall not apply in respect of Residential Parking Places, the Lorry and Coach Parking Place or Free Parking Places.



### **Power to close or suspend parking places**

27. By conspicuous notices to the effect the Council may suspend parking on or close the Parking Place, or part thereof for any period or for use only by particular vehicles or organisations and failure to observe such notices shall be a contravention of this Order.
28. No person shall cause or permit a vehicle to be left in a Parking Place, or any part thereof during the period where that Parking Place is closed or use of that Parking Place suspended in accordance with Article 26.

## **PART III**

### **CONTRAVENTION AND PENALTY CHARGE**

29. Where a Driver has left a vehicle in a Parking Place, in contravention of this Order a Penalty Charge shall become payable. A Penalty Charge Notice to that effect will be attached to the vehicle or handed to the Driver by a Civil Enforcement Officer,
30. A Penalty Charge shall be payable to the Enforcement Authority.
31. In the event of payment of the Penalty Charge being received by the Enforcement Authority within 14 days of the day in which it was incurred the amount of penalty charge will be discounted in accordance with the General Regulations 2007.
32. A Penalty Charge Notice referred to in Article 29 and issued by a Civil Enforcement Officer shall include the following particulars:
  - (a) the enforcement authority,
  - (b) the parking place at which the contravention occurred, (which may be identified on the Penalty Charge Notice by an abbreviation or code)
  - (c) the registration mark of the vehicle or when the vehicle is being used under a trade licence, the registration mark of that trade licence,
  - (d) the date and time at which the Penalty Charge was seen to be payable,
  - (e) the grounds on which the Civil Enforcement Officer serving the Penalty Charge Notice believes that a Penalty Charge is payable,
  - (f) the amount of the Penalty Charge,
  - (g) the manner in which and time within which the Penalty Charge shall be payable,
  - (h) a statement that a reduced charge may be payable if payment is made within fourteen days of the Penalty Charge Notice being incurred,
  - (i) a statement to the effect that if the Penalty Charge is not paid before the end of the period of 28 days a notice to owner may be served by the Enforcement Authority on the owner of the vehicle.

- (j) the provisions required by paragraph 3(2) of The Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulations 2007.
33. Where a Driver has left a vehicle in a Parking Place in contravention of this Order and a Penalty Charge Notice could not be issued as specified in Article 29 of this Order a penalty Charge Notice may be issued by post by the enforcement authority in accordance with Regulation 10 of the General Regulations 2007.
34. A Penalty Charge Notice referred to in Article 33 and issued by post by the Enforcement Authority in accordance with section 10 of the General Regulations 2007 shall in addition to the particulars specified in Article 32 include the particulars specified in paragraph 2 of the Schedule to the General Regulations 2007.
35. The Penalty Charge referred to in Article 33 shall be paid to the Enforcement Authority or an agent acting on behalf of the Enforcement Authority in accordance with the instructions on the reverse of the Penalty Charge Notice.
36. The Driver of a vehicle in respect of which a Penalty Charge has been incurred shall pay the Penalty Charge or provide proof of payment of the Penalty Charge to the Enforcement Authority as detailed on the reverse of the Notice within 28 days of the date of which the notice is served. If payment is received within a period of 14 days beginning on the date on which the notice is served the amount of the said charge shall be reduced by 50% (provided that if the fourteenth day falls upon a day on which the Enforcement Authority's offices are closed the period within which payment of the said charge is due shall be extended to 1.00 p.m. on the next full day on which the office is open).
37. Where a Driver of a vehicle fails to pay the Penalty Charge as specified in Article 36 the Enforcement Authority may follow the procedures set out in the General Regulations 2007 to recover the Penalty Charge.
38. A Driver who desires to make representation to or appeal against a Penalty Charge Notice issued to him may make representation or appeal to the Enforcement Authority pursuant to the procedures set out in the Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulations 2007.
39. When a Penalty Charge Notice has been attached to a vehicle in accordance with the provisions of Article 29 no person, not being the Driver of the vehicle or a person duly authorised by the Council shall remove the Notice from the vehicle unless authorised to do so by the Driver.

#### **PART IV**

#### **RELOCATION AND REMOVAL OF VEHICLES**

40. Subject to the proviso hereto, when a vehicle is left in the Parking Place, in contravention of any of the provisions of this Order, or it is necessary to meet the requirements of an emergency, a person authorised on behalf of the Council or a Civil Enforcement Officer may remove the vehicle or arrange for it to be removed from the Parking Place, or may alter or cause to be altered the position of the vehicle

in order that its position shall comply with those provisions or meet the requirements of the emergency.

41. Any person removing or altering the position of a vehicle by virtue of Article 40 of this Order may do so by towing or driving the vehicle or in such other manner as that person may think necessary and may take such measures in relation to the vehicle as that person may think necessary to enable that person to remove or alter its position.
42. When a person authorised by the Council or a Civil Enforcement Officer removes or makes arrangements for the removal of a vehicle from the Parking Place, by virtue of Articles 40 and 41 of this Order, that person shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.
43. Where a vehicle has been removed in accordance with Articles 40, 41 and 42 of this Order the charges as specified in paragraph 3 to the Schedule of the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges)(England) Order 2007 shall become payable.

## **PART V LIABILITIES AND PENALTIES**

44. The Council shall not be responsible for any loss or damage to the vehicle or to anything contained therein or attached thereto arising from or in consequence of the exercise of the powers contained in Articles 40 to 43.
45. The Council accepts no liability for the loss or damage to vehicles or other property left in any Parking Place.

## **PART REVOCATIONS**

46. The following Orders and Variation Notices will become revoked on the date of commencement of this Order as follows:-
