Gwynedd Council (hereinafter referred to as "the Council") in exercise of the powers conferred by the Road Traffic Regulation Act 1984, as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1994 hereby makes the following Order:-

- 1.1 This Order shall come into operation on the 23<sup>rd</sup> day of November Two Thousand and Nine and may be cited as the Gwynedd Council (Prohibition and Restriction of Waiting and Street Parking Places) (Consolidation Order 2007) Variation Order (No. 9 Nefyn and Morfa Nefyn) 2009
- 1.2 In this Order the expression "the 2007 Order" means the Gwynedd Council (Prohibition and Restriction of Waiting and Street Parking Places) Consolidation Order 2007 as varied.
2. The 2007 Order shall have effect as though the Plans attached to this Order replaced those Plans bearing the same Section Area Code in the 2007 Order.
3. In all other respects the 2007 Order is confirmed.
