NOTICE OF VARIATION OF CHARGES AT DESIGNATED PARKING PLACES

NOTICE is hereby given that on 10 October 2016 North Yorkshire County Council made an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1) and 45 to 49 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which is to revoke the current Pay and Display controls in Harrogate Town which apply between 8.00 am and 6.00 pm from Monday to Saturday and introduce revised controls on all of those streets (listed below) which will apply not only between 8.00 am and 6.00 pm from Monday to Saturday but also between 10.00 am and 6.00 pm on Sundays. Notice is also given under Section 46A of the Road Traffic Regulation Act 1984 that the Monday to Saturday charges will subsequently be varied and that the variation will come into operation on 7 November 2016 together with the implementation of the Sunday charges, which will also be varied - the current and revised charges are set out in the table below.

The overall effect of the increase in on-street parking tariffs will therefore be as follows:-

- Short stay – increase in tariff by £0.10 per 20 minutes
- Inner zone – increase in tariff by £0.10 per 30 minutes
- Outer zone – increase in tariff by £0.10 per 30 minutes

If you wish to question the validity of the Order or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order, you may, within six weeks of 10 October 2016 make application to the High Court for the purpose.
