# THE BOROUGH OF HAVANT (BULBECK ROAD, HAVANT) ONE-WAY STREET ORDER 2005

The Council of the Borough of Havant (hereinafter referred to as "*the Council*") pursuant to arrangements made under Section 101 of the Local Government Act 1972, with the County Council of Hampshire in exercise of the powers conferred on that County Council under Sections 1(1), 2(1) and (2) and 4(2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "*the Act*") and Part IV of Schedule 9 to the Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

# Part 1 - One-Way Traffic

1 No person shall except upon the direction or with the permission of a Police Constable in Uniform cause any vehicle to proceed in any of the length of road specified in Column 1 of Schedule 1 to this Order in a direction other than that specified in relation to that length of road in Column 2 of the said schedule.

#### Part 2 – Interpretation, Commencement and Repeals

- 2 The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 3 The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
- 4 The restrictions and prohibitions imposed by Article 1 of this Order are for identification purposes only illustrated and shown annotated on plan Hi12/204 annexed hereto.
- 5 This Order shall come into operation on 15 March 2006 and may be cited as "The Borough of Havant (Bulbeck Road, Havant) One-Way Street Order 2005".

### Column 1

# Length of Road

The entire length of Bulbeck Road from its northern junction with Park Road South, to its junction with Park Road South.

#### Column 2

#### **Direction of Traffic**

Commencing at its northernmost junction with Park Road South, eastwards thence southwards and thence westwards to its southernmost junction with Park Road South.
