## <u>THE BOROUGH OF HAVANT</u> (WATERLOOVILLE: MILL ROAD, REGENCY GARDENS AND BRIGHTSIDE) (PROHIBITION OF LOADING AND UNLOADING) ORDER 2009

The Council of the Borough of Havant hereby gives notice that pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Council of the County of Hampshire in exercise of the powers conferred on that County Council under Sections 1 (1) 2 (1) and (2) and 4 (2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the sixteenth day of February 2009 and may be cited as "The Borough of Havant (Waterlooville: Mill Road, Regency Gardens and Brightside) (Prohibition of Loading and Unloading) Order 2009.
- 2. Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 3. Save as provided in Article 4 no person shall except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to be loaded or unloaded in the lengths of roads specified in the Schedule to this Order.
- 4. Nothing in Article 3 shall render it unlawful to cause or permit any vehicle to wait on the lengths of roads specified in the Schedule to this Order for so long as may be necessary:-
  - (a) to enable a person to board or alight from a vehicle.
  - (b) to enable a vehicle to be used by the emergency services in pursuance of their statutory powers or duties.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
