

THE BOROUGH OF HAVANT
(PURBROOK: ALAMEDA ROAD, JACQUELINE AVENUE, KENNEDY CLOSE, PARK
AVENUE, PRIVETT ROAD, STAKES ROAD AND ST JOHNS AVENUE)
(PROHIBITION OF WAITING) ORDER 2016

The Council of the Borough of Havant hereby gives notice that pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Council of the County of Hampshire in exercise of the powers conferred on that County Council under Sections 1 (1), 2 (1), (2), 4 (2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the First day of July 2016 and may be cited as "The Borough of Havant (Purbrook: Alameda Road, Jacqueline Avenue, Kennedy Close, Park Avenue, Privett Road, Stakes Road and St Johns Avenue) (Prohibition of Waiting) Order 2016".
2. (1) In this Order -
 - "**Civil Enforcement Officer**" means a person (being a person appointed under Section 76 of the Traffic Management Act 2004 and/or under Section 63A of the 1984 Act) authorised by or on behalf of the Council to supervise any parking place and act as indicated by the use of the expression in any of the Articles in this Order;
 - "**Council**" means the Council of the Borough of Havant;
 - "**delivering**" and "**collecting**" in relation to any goods includes checking the goods for the purpose of their delivery or collection;
 - "**disabled person's badge**" or "**blue badge**" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 SI 682;
 - "**Disabled Persons' Parking Place**" means a area on a highway which is designated as a disabled persons' parking place and is comprised within and indicated by a road marking complying with diagram 1028.3 or diagram 1033 of the Traffic Signs Regulations and General Directions 2002;
 - "**disabled person's vehicle**" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986 as amended;
 - "**loading**" means the loading or unloading of goods to or from a vehicle;
- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge or a parking disc in the relevant position when and only when they are displayed in accordance with Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
- (3) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. Save as provided in Article 4 no person shall except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer cause or permit any vehicle to wait in the lengths of roads specified in the Schedule to this Order.

Alameda Road	<p>North-east side:-</p> <ul style="list-style-type: none"> • from its junction with Park Avenue, south-eastwards for a distance of 11 metres <p>South-west side:-</p> <ul style="list-style-type: none"> • from its junction with Park Avenue south-westwards for a distance of 21 metres
Jacqueline Avenue	<p>East side:-</p> <ul style="list-style-type: none"> • from its junction with Kennedy Close, southwards for a distance of 13 metres. • from its junction with Stakes Road, northwards for a distance of 17 metres. <p>West side:</p> <ul style="list-style-type: none"> • from its junction with Kennedy Close, southwards for a distance of 29.5 metres. • from its junction with Stakes Road, northwards for a distance of 14 metres.
Kennedy Close	<p>South side:-</p> <ul style="list-style-type: none"> • from the centreline of its junction with Jacqueline Avenue, eastwards and westwards for distances of 15.5 metres.
Park Avenue	<p>Both sides:-</p> <ul style="list-style-type: none"> • from its junction with Stakes Road, southwards for distances of 13 metres. <p>East side:-</p> <ul style="list-style-type: none"> • from the centreline of its junction with Privett Road, northwards for a distance of 17 metres. • from the centreline of its junction with Privett Road, southwards for a distance of 14 metres.

Stakes Road	South side:- <ul style="list-style-type: none"> from the centreline of its junction with Park Avenue, eastwards and westwards for distances of 45.5 metres and 43.5 metres respectively.
