

THE COUNTY OF HEREFORD AND WORCESTER 410 05/3

(PRIORS WALK SERVICE ROADS, HEREFORD)

(PROHIBITION OF ENTRY) ORDER 1977

The County Council of Hereford and Worcester in exercise of their power under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

1. No person shall cause any motor vehicle proceeding in any of the roads specified in Column 1 of the Schedule to this Order to enter the road specified in relation to that road in Column 2 of the said Schedule.
2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing any motor vehicle to proceed in the length of roads specified in that Article if the vehicle:-
  - (a) is being used for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the lengths of roads;
  - (b) is being used for the purposes of agriculture in connection with land adjacent to the lengths of roads or for the conveyance or haulage of timber felled upon that land;
  - (c) is being used in connection with any building operation or demolition in or adjacent to the lengths of roads, the removal of any obstruction to traffic in the lengths of roads, the maintenance, improvement or reconstruction of the lengths of roads, or the laying, erection, alteration or repair in or adjacent to the lengths of roads of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act
  - (d) is being used in an emergency for fire brigade, police or ambulance purposes;
  - (e) is to be garaged, serviced or repaired at any premises situated on or adjacent to the lengths of roads;
  - (f) is being used in the service of a local authority in pursuance of statutory powers or duties.
3. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

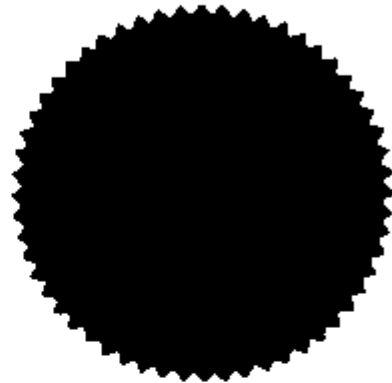
4. This Order shall come into operation on the **21st** day of **January** 1977, and may be cited as the County of Hereford and Worcester (Priors Walk Service Roads, Hereford) (Prohibition of Entry) Order 1977.
