(GRIMMER ROAD AND POMONA PLACE, HEREFORD)

21st Nov 1986

(PROHIBITION AND RESTRICTION OF WAITING) ORDER 1986

Hereford and Worcester County Council in exercise of their powers under Section 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. Save as provided in Articles 3 and 4 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the sides of lengths of roads in the City of Hereford in the County of Hereford and Worcester specified in the First Schedule to the Order.
2. Save as provided in Articles 3 and 5 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 8.00 am and 6.30 pm on Monday to Saturday inclusive on the sides of lengths of roads in the City of Hereford in the County of Hereford and Worcester specified in the Second Schedule to the Order :-
 - (i) for a period exceeding one hour; or
 - (ii) if a period of less than one hour has elapsed since the termination during the said hours of the hours of the last period of waiting (if any) by that vehicle on the sides of lengths of roads.
3. Nothing in Articles 1 and 2 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads referred to in those Articles for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded onto and/or unloaded from the vehicle;
 - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the sides of lengths of roads referred to, or the laying, erection, alteration or repair in or near the said sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984;

- (d) to enable the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in pursuance of statutory powers or duties;
 - (e) for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
 - (f) for the purpose of removing furniture and effects from one office or dwellinghouse to another, or to such premises from a depository or from such premises to a depository, provided notice is given twenty-four hours in advance to the police, their consent is obtained and such reasonable conditions as they may impose are complied with;
 - (g) for fire brigade, police or ambulance purposes.
4. Nothing in Article 1 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in the sides of lengths of roads referred to in that Article for a period not exceeding two hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same sides of lengths of roads on the same day).
5. The restriction imposed by Article 2 of this Order shall not apply to a disabled person's vehicle left by the driver thereof being a vehicle which displays in accordance with the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1971 as amended, a badge issued under the Disabled Persons' (Badges for Motor Vehicles) Regulations 1975, in pursuance of a scheme under Section 21 of the Chronically Sick and Disabled Persons Act 1970.
6. (1) In this Order:-
- "disabled person's badge" has the same meaning as in The Disabled Persons' (Badges for Motor Vehicles) Regulations 1975;
- "disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons) (England and Wales) (Amendment) Regulations 1975;
- "parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No. 4631 : 1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.
- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-

(a) a disabled person's badge in the relevant position, when -

(i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen; and


(ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle;

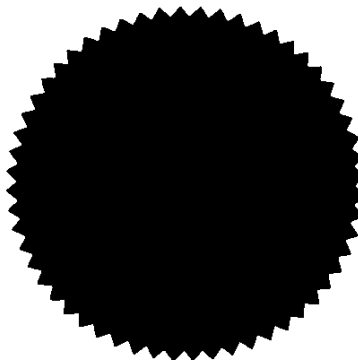
(b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.

7. This Order shall come into operation on 21st day of November 1986 and may be cited as The County of Hereford and Worcester (Grimmer Road and Pomona Place, Hereford) (Prohibition and Restriction of Waiting) Order 1986.

FIRST SCHEDULE

Sides of lengths of roads in the City of Hereford in the County of Hereford and Worcester.

Grimmer Road

West Side

- a) from its junction with A438 Whitecross Road to its junction with Melrose Place.
- b) from its junction with Melrose Place to its junction with Pomona Place.

East side

- a) from its junction with A438 Whitecross Road for a distance of 90 metres (295 feet) in a southerly then easterly direction.
- b) from a point 20 metres (65 feet) south of the south side of its junction with Pomona Place for a distance of 40 metres (131 feet) in a northerly direction.

Pomona Place

North side

from its junction with Grimmer Road for a distance of 50 metres (164 feet) in a westerly direction to its termination.

South side

from its junction with Grimmer Road for a distance of 13 metres (43 feet) in a westerly direction.

SECOND SCHEDULE

Sides of lengths of roads in the City of Hereford in the County of Hereford and Worcester.

Grimmer Road

East Side

from a point 20 metres (65 feet) north of the south side of its junction with Pomona Place for a distance of 65 metres (213 feet) in a northerly direction.

Pomona Place

South side

from a point 13 metres (43 feet) west of its junction with Grimmer Road for a distance of 31 metres (102 feet) in a westerly direction to its termination.
