

ROAD TRAFFIC REGULATION ACT 1984

**GRANDSTAND ROAD, HEREFORD
(PROHIBITION OF WAITING) (VARIATION) ORDER 2000**

The County of Herefordshire District Council in exercise of their powers under Section 1 of the Road Traffic Regulation Act 1984 (referred to as "the 1984 Act") and Part IV of Schedule 9 to the Act of 1984 and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- 1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before coming into operation of this Order, The County of Hereford and Worcester (Grandstand Road, Hereford) (Prohibition of Waiting) Order 1995 ("the 1995 Order") is hereby varied and shall have effect as though the provisions of the Schedule to the 1995 Order are extended as follows:-


Grandstand Road south-west side:-

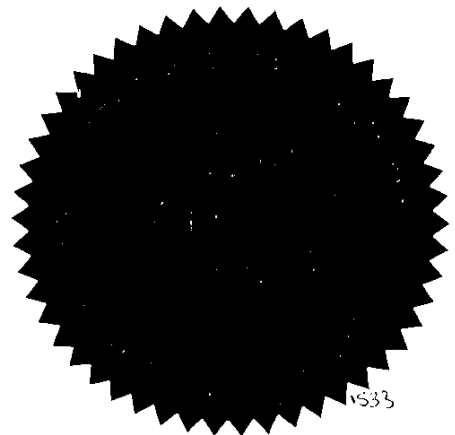
- i) from where existing restrictions finish adjacent to number 17 for a distance of 25 metres in a south-westerly direction to the junction with the north-western kerb line of Armadale Close.
- ii) from its junction with the south-eastern kerb line of Armadale Close adjacent to number 9 Grandstand Road for a distance of 15 metres in a south-easterly direction.

2. This Order shall come into operation on the 8th day of May 2000 and may be cited as The County of Herefordshire District Council (Grandstand Road) (Prohibition of Waiting) (Variation) Order 2000.
