ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF HEREFORD AND WORCESTER

(HOLMER STREET AND COTTERELL STREET, HEREFORD)

(PROHIBITION AND RESTRICTION OF WAITING) ORDER 1992

Hereford and Worcester County Council in exercise of their powers under Sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

- Save as provided in Articles 4 and 5 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the length and sides of lengths 1. of roads in the City of Hereford in the County of Hereford and Worcester specified in the Schedule to this Order.
- Save as provided in Articles 4 and 5 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours 8.00 a.m. and 6.30 p.m. on 2. Monday to Saturday inclusive, on the western side of length of Holmer Street in the City of Hereford and the County of Hereford and Worcester from a point opposite the southern kerbline of Cotterell Street for a distance of 46 metres (15 feet) in a southerly direction.
- Save as provided in Articles 4 and 6 of this Order, no person shall, except upon the direction or with permission of a police officer in uniform of of a traffice warden, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.30 p.m. 3. on Monday to Saturday inclusive, on the eastern side of length of Holmer Street in the City of Hereford in the County of Hereford and Worcester from a point 10 metres (33 feet) south of the southern kerbline of Cotterell Street for a distance of 36 metres (118 feet) in a southerly direction:
 - for a period exceeding 2 hours; (a)
 - if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the side of (i) length of road.
 - Nothing in Articles 1,2 or 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the length and sides of lengths of roads referred to in those 4. Articles for so long as may be necessary:
 - to enable a person to board or alight from the vehicle;
 - to enable goods to be loaded onto and/or unloaded from the vehicle; (b)
 - to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, (c) improvement or reconstruction of the length and sides of lengths of roads referred to, or the laying, erection, alteration or repair in or near the said length and sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act
 - to enable the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in pursuance of statutory powers or duties; (d)

(PROHIBITION AND RESTRICTION OF WAITING) ORDER 1992

NOTICE is hereby given that on 30th April 1992 Hereford and Worcester County Council made an Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, and of all other enabling powers the effect of which be:-

- to prohibit waiting at any time on the length of sides of lengths of roads in the City of Hereford in the County of Hereford and Worcester specified in the Schedule to this (1)Notice;
- to prohibit waiting between the hours of 8.00 a.m. and 6.30 p.m. on Monday to Saturday inclusive, on the western side of the length of Holmer Street in the City of Hereford in the County of Hereford and Worcester from a point opposite the southern (2)kerbline of Cotterell Street for a distance of 46 metres (151 feet) in a southerly direction.
- to limit waiting between the hours of 8.00 a.m. and 6.30 p.m. on Monday to Saturday inclusive on the eastern side of the length of Holmer Street in the City of Hereford in the County of Hereford and Worcester from a point 10 metres (33 feet) (3)south of the southern kerbline of Cotterell Street for a distance of 36 metres (118 feet) in a southerly direction to a period not exceeding 2 hours, return prohibited within 2 hours.

Exemptions in the Order will permit waiting for the purpose of:-

- picking up and setting down passengers; (a)
- loading and/or unloading goods; (b)
- delivering and collecting mail by Post Office vehicles;
- delivering and collecting furniture and effects with Police consent; (c) (d)
- any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply and maintenance of any gas, electricity, (e) water and telecommunications apparatus;
- the fire brigade, ambulance or police services; (f)
- the pursuance of statutory powers of duties (if not other roads can conveniently be (g)

Exemptions in the Order also permit disabled persons' vehicles displaying a badge and parking disc issued under the Local Authority's Orange Badge Scheme to wait:-

- on the length and sides of lengths of roads referred to in the Schedule to this Notice and paragraph (2) above for a maximum of 2 hours (return prohibited within one (a)
- on the side of length of road referred to in paragraph (3) above at any time on any (b)

The Order will come into operation on 11th May 1992.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant Section of the Act or on the ground that any requirement of that Section or of Parts I, II or III of Schedule 9 to the Act of 1984 ground that any requirement of that Section of or ranks 1, if of in or Schedule 3 to the Act of 1304 or of any regulations made under the said Part III of Schedule 3 have not been complied with in relation to the Order, may within 6 weeks of the date on which the Order were made (such date stated in this Notice) make application for the purpose to the High Court.


Lengths and sides of lengths of roads in the City of Hereford in the County of Hereford and Worcester.
