ROAD TRAFFIC REGULTION ACT, 1967

THE COUNTY OF REASEORD AND MORCESTER

(MONDOU CLOSE AND GREENCROME, HATTHEFORD) (PROFIDENCE OF THROUGH TRAFFIC) ORDER, 1976

The County Council of Hereford and Worcester, in exercise of their powers under Section 1(1), (2) and (3) of the Road Truffic Regulation Act, 1967, as smended by Fart IX-of the Transport Act, 1968 and Schedule 19 to the Local Government Act 1972 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967"), and Schedule 6 to the Road Truffic Act, 1974 and of all other enabling Schedule 6 to the Road Truffic Act, 1974 and of all other enabling powers, and after consultation with the Chief Officer of Folice in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:

1. No person shall cause any motor vehicle to proceed along the following lengths of roads, in the County of Hereford and Vorcester

Honddu Close, Hereford

- (a) from its junction with Dulas Avenue to its junction with Greencroft; or
- (b) from its junction with Greencroft to its junction with Dulas Avenue.

Greencroft, Hereford

- (a) from its junction with Honddu Close to its junction with Standale Road; or
- (b) from its junction with Standale Road to its junction with Honddu Close.
- 2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing any motor vehicle to proceed in the lengths of roads specified in that Article if the vehicle:-
 - (a) is being used for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the lengths of roads;
 - (b) is being used for the purposes of agriculture in connection with land adjacent to the lengths of reads or for the conveyance or haulage of timber felled upon that land;
 - (c) is being used in connection with any building operation or description in or adjacent to the lengths of reads, the removal of any ebstruction to traffic in the lengths of roads, the maintenance, improvement or reconstruction of the lengths of roads, or the laying, erection, alteration or repair in or adjacent to the lengths of reads of any sever or of say main, page or apparatus for the supply of gas, water of of say main, page or apparatus for the supply of gas, water clearing a country or of any telegraphic line as defined in the Telegraph Act, 1878;

THE COUNTY OF HEREFORD AND WORCESTER (HUNDERTON ROAD, HEREFORD) (PROHIBITION OF WAITING) ORDER 1993

On 3rd August 1993 Hereford and Worcester County Council made an Order which will prohibit waiting at any time on both sides of Hunderton Road, Hereford from its junction with A465 Belmont Road to a point 40 metres north west of its junction with Hunderton Avenue.

The Order will come into operation on 23rd August 1993.

The Order contains exemptions to allow parking for certain purposes and limited waiting by disabled persons vehicles.

A copy of the Order, relevant map, and Statement of Reasons for making the Order may be inspected at County Hall, Spetchley Road, Worcester, WR5 2NP during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court by 14th September 1993.
