### **ROAD TRAFFIC REGULATION ACT 1984**

# (PROHIBITION AND RESTRICTION OF WAITING AND RESTRICTION OF LOADING AND UNLOADING) ORDER 1992

Hereford and Worcester County Council in exercise of their powers under Sections 1(1) and (2), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

- The Herefordshire County Council (Various Roads, Ross-on-Wye) (Consolidation and Amendment of Waiting Restrictions) Order 1972 is hereby varied with effect that:
  - (a) item 3 of Schedule 6 thereof relating to the east side of Brookend Street was amended to read:-

### "3. Brookend Street -

East Side: from a point 50 yards North of its junction with Station Street in a Northerly direction for a distance of 50 yards.

- (b) item 2 of Schedule 7 thereof relating to the east side of Edde Cross Street was deleted therefrom;
- (c) item 6 of Schedule 3 thereof relating to Edde Cross Street was amended to read:-

### "6. Edde Cross Street -

East Side: from its junction with High Street to its junction with New Street and from a point 33 yards North of its junction with New Street to its junction with Kyrle Street".

- (d) item 2 of Schedule 5 thereof relating to the west side of Henry Street was deleted therefrom.
- (e) item 1 of Schedule 7 thereof relating to the south side of Station Street was amended to read:-

## "1. Station Street -

South Side: from a point 40 metres (131 feet) east of its junction with Broad Street to a point 7 metres (23 feet) west of its junction with Henry Street and from a point 10 metres (33 feet) east of its junction with Henry Street to a point 25 metres (82 feet) west of its junction with Millpond Street."


- 2. The Herefordshire County Council (Millpond Street and Greenpits Road, Ross-on-Wyell (Prohibition of Waiting) Order 1974 is hereby varied with effect that:-
  - (a) that part of Schedule 2 thereof relating to the west side of Millpond Street was amended to read:-
    - "Millpond Street, West Side, from a point 34 metres (112 feet) east and their south of its junction with Brookend Street to a point 20 metres (60 feet) north of its junction with Station Street".
  - (b) that part of Schedule 2 thereof relating to the south side of Greenpits Road was deleted therefrom.
- 3. Save as provided in Articles 6 and 7 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warder, cause or permit any vehicle at any time on those sides of lengths of roads in the Town on Ross-on-Wye in the District of South Herefordshire in the County of Hereford and Worcestershire specified in the First Schedule to this Order.

- Save as provided in Articles 6 and 8 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait between the hours of 9.00a.m. and 6.00p.m. Monday to Saturday inclusive, on those sides of lengths of roads in the Town of 4. Ross-on-Wye in the District of South Herefordshire in the County of Hereford and Worcester specified in the Second Schedule to this Order:
  - for a period exceeding 40 minutes;
  - not being a period separated by an interval of less than 80 minutes from a previous period of waiting by the same vehicle in the same sides of lengths (i) (ii) of roads on the same day.
  - Save as provided in Articles 6 and 7 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait or to load and unload between the hours of 8.00a.m. and 9.30a.m. and 4.30p.m. and 6.00p.m. Monday to Saturday inclusive on those lengths of roads 5. in the Town of Ross-on-Wye in the District of South Hereford in the County of Hereford and Worcester specified in the Third Schedule to this Order.
    - Nothing in Articles 3,4 and 5 of this Order shall render it unlawful to cause or perm t any vehicle to wait in the sides of lengths of roads referred to in those Articles for 6. so long as may be necessary to enable:
      - a person to board or alight from the vehicle;
      - the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or (b) reconstruction of the sides of lengths of roads referred to, or the laying erection, alteration or repair in or near the said sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
        - the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties; (c)
        - the vehicle to be used for the purpose of delivering or collecting postal (d) packets as defined in Section 87 of the Post Office Act 1953;
        - the vehicle to be used for the purpose of removing furniture and effects from (e) one office or dwellinghouse to another, or to such premises frcm a depository or from such premises to a depository, provided notice is given twenty-four hours in advance to the police, their consent is obtained and such reasonable conditions as they may impose are complied with;
        - the vehicle to be used for fire brigade, police or ambulance purposes. (f)
      - 7. Nothing in Articles 3 and 5 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in the sides of lengths of roads referred to in Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same sides of lengths of roads on the same day).
      - 8. In this Order:-

()

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982; "disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986;

"parking disc" means a disc, issued by a local authority, 125 millimatres square, coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.



- (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen; and
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle;
- (b) a disabled persons badge issued on or after 2nd March 1992 in the relevant position, when:-
  - (i) in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part I of the badge is legible from outside the vehicle; and
  - (ii) in the case of a vehicle not fitted with a dashboard or facia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part I of the badge is legible from outside the vehicle.
- (c) a parking disc in the relevant position, when:-
  - (i) in the case of a vehicle fitted with a dashboard or facia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; and
  - (ii) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle.
- 9. The restriction imposed by Article 5 of this Order shall not apply to a disabled person's vehicle left by the driver thereof being a vehicle which displays in accordance with the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986, a badge issued under the Disabled Persons (Badges for Motor Vehicles) Regulations 1982, in pursuance of a scheme under Section 21 of the Chronically Sick and Disabled Persons Act 1970.
- 10. The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
- 11. This Order shall come into operation on the day of 1992 and may be cited as The County of Hereford and Worcester (Various Roads, Ross-on-Wye) (Prohibition and Restriction of Waiting and Restriction of Loading and Unloading) Order 1992.

  - the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
  - the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;

    - in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle;
  - (b) a disabled persons badge issued on or after 2nd March 1992 in the relevant position, when:-
    - in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part I of the badge is legible from outside the vehicle; and
    - (ii) in the case of a vehicle not fitted with a dashboard or facia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part I of the badge is legible from outside the vehicle.
  - (c) a parking disc in the relevant position, when:-
    - (i) in the case of a vehicle fitted with a dashboard or facia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; and
    - (ii) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle.

- 12. This Order shall come into operation on the 26th day of November 1993 and may be cited as The County of Hereford and Worcester (Various Roads, Ross-on-Wye) (Prohibition and Restriction of Waiting and Restriction of Loading and Unloading) Order 1993.
