

THE COUNTY OF HEREFORD AND WORCESTER (ROSS-ON-WYE TOWN CENTRE)  
VARIOUS ORDERS 1997

On 11 December 1997 Hereford and Worcester County Council made an Order which will :-

**(a) make the following roads one-way, except for road cleansing vehicles, in the directions indicated:-**

**Broad Street** from its junction with High Street to its junction with Kyrle Street in a northerly direction.

**New Street** from a point 40 metres north west of its junction with Broad Street to its junction with Broad Street in an easterly direction.

**(b) prohibit vehicles of over 3.5 tonnes maximum gross weight from using the following lengths of roads:-**

**Broad Street** from its junction with High Street to its junction with Brookend Street; **Brookend Street** from its junction with Broad Street to its junction with Millpond Street; **New Street** from its junction with Edde Cross Street to its junction with Broad Street; **Station Street** from its junction with Millpond Street to its junction with Brookend Street and **Henry Street** from its junction with Station Street to its junction with Cantilupe Road.

**(c) provide goods vehicle loading bays, (30 minutes duration), in Broad Street, West side** from a point 8 metres north of its junction with High Street for a distance of 44 metres in a northerly direction. from a point 33.5 metres south of its junction with Kyrle Street to a point 18.5 metres south of its junction with Kyrle Street and **East side** from a point 33 metres south of its junction with New Street for a distance of 14 metres in a southerly direction and from a point 25 metres north of its junction with with New Street for a distance of 17 metres in a northerly direction.

**(d) limit waiting to 60 minutes with no return within 1 hour between 9.00am and 6.00pm, Monday to Saturday, on Broad Street, West side** from a point 19 metres north of its junction with New Street for a distance of 35.5 metres in a northerly direction, from a point 59 metres north of its junction with New Street for a distance of 13 metres in a northerly direction and from a point 30 metres south of its junction with Kyrle Street for a distance of 35.5 metres in a southerly direction. **This order contains exemptions to allow parking by disabled persons vehicles.**

**(e) provide parking for disabled persons vehicles only (60 minutes duration) in Broad Street, West side** from a point 72 metres north of its junction with New Street to a point 33.5 metres south of its junction with Kyrle Street and **East side** from a point 42 metres north of its junction with New Street for a distance of 12 metres in a northerly direction. **This order contains exemptions to allow parking at specified times and for certain purposes outside the Baptist Church.**

**(f) prohibit waiting, loading and unloading in Broad Street, west side** from its junction with High Street for a distance of 8 metres in a northerly direction, from a point 52 metres north of its junction with High Street to a point 19 metres north of its junction with New Street and **East side** from its junction with High Street to a point 47 metres south of its junction with New Street, from a point 33 metres south of its junction with New Street to a point 25 metres north of its junction with New Street.

**(g) prohibit waiting at any time (except for Hackney Carriages) in Broad Street, East side** from a point 18.5 metres south of its junction with Kyrle Street for a distance of 11 metres in a southerly direction.

A copy of the Order, relevant map, Statement of Reasons for making the Order and affected existing regulations may be inspected at South Herefordshire District Council, Brockington, 35 Hafod Road, Hereford HR1 1SH and County Hall, Spetchley Road, Worcester, WR5 2NP during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court by 15 January 1998.
