(CHURCH STREET, BROMYARD)

(PROHIBITION OF WAITING) ORDER 1978"

The County Council of Hereford and Worcester, in exercise of their powers under Section 1(1), (2) and (3) of the Read Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 to the Read Traffic Act 1974 (which said Act of 1967, as so amended, is hereinafter referred to as 'the Act of 1967'), and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

1. Save as provided in Articles 2 and 3 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the west side of Church Street, Bromyard (B.4203) in the Parish of Bromyard and Winslow in the District of Malvern Hills in the County of Hereford and Woreester from a point 95 metres (312 feet) north of its junction with Rowberry Street for a distance of 20 metres (66 feet) in a northerly direction and on that length of the access read to St. Peter's Churchyard from its junction with Church Street for a distance of 20 metres (66 ft.) in a north westerly direction.

2. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vohicle to wait in the side of length of read and length of read referred to in that Article for so long as may be necessary to enable:-

- (a) a person to board or alight from the vehicle;
- (b) goods to be loaded and unloaded from the vehicle;
- (c) the vehicle, if it cannot conveniently be used for such purpose in any other read, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the side of the length of read and length of read referred to or the laying, creation, alteration or repair in or near to the said side of length of read and length of read of any sower or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any tolegraphic line as defined in the Tolegraph Act 1878;
- (d) the vohiclo, if it cannot conveniently be used for such purposes in any other read, to be used in pursuance of statutory powers or duties;
- (c) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
- (f) the vehicle to be used for the purpose of removing furniture and effects from one office or dwellinghouse to another or to such premises from a depository or from such premises to a depository, provided notice is given twenty-four hours in advance to the police, their consent is obtained and such reasonable conditions as they may impose are complied with;

- (g) the vehicle to wait at or near to any premises situated on or adjacent to the side of length of read and length of read for long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral.
- (h) the vehicle to be used for fire brigade, ambulance or police purposes.

3. Nothing in Articlo 1 of this Order shall apply to a disabled person's vohicle being a vohicle which displays in accordance with the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1971, as anonded, a badge issued under the Disabled Persons (Badge for Motor Vehicles) Regulations 1975, in pursuance of a scheme under Section 21 of the Chromically Sick and Disabled Persons Act 1970.

4. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

5. This Order shall come into operation on the 26 thay of May 1978, and may be cited as the County of Hereford and Worcester (Church Street, Bronyard) (Prohibition of Waiting) Order 1978.
