ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF HEREFORD AND WORCESTER

(A438 HIGH STREET, LEDBURY)

(PARKING PLACES FOR DISABLED PERSONS VEHICLES) ORDER 1997

Hereford and Worcester County Council (hereinafter referred to as "the Council") in exercise of their powers under Section 32(1), 35(1) and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other enabling powers, and with the consent of every authority and person responsible for the maintenance of the roads affected by the Order and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby making the following Order:-

1. (a) The County of Hereford and Worcester (High Street, Ledbury) (Street Parking Places) Order 1977 is hereby varied and shall have effect as though the description of High Street in the Schedule thereto was amended to read:-

* "A438 High Street, Ledbury - east side, from the Market House southwards for a distance of 45 metres."
2. (1) Each of the parts of the road specified in column 1 of the Schedule to this Order is authorised to be used, subject to the following provisions of this Order, as a parking place for such classes of vehicles and in such positions as are specified in relation to that part of road in the said Schedule;

(2) Nothing in paragraph (1) of this Article shall restrict the power of the Council, for preventing obstructions of streets, by order on the occasion of any public procession, rejoicing or illumination, or where the streets are thronged or liable to be obstructed, to close any parking space.
3. Where in the Schedule to this Order a parking place is described as available for vehicles of a specified class or in a specified position, the driver shall not permit the vehicle to wait in that parking place:-
 - (a) unless it is of the specified class; or
 - (b) in a position other than that specified.
4. Nothing in Article 3 hereof shall render it unlawful to cause or permit any vehicle to wait in any parking place for so long as may be necessary to enable:-
 - (a) the vehicle to be used in connection with any of the following operation, namely:-

- (i) building or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the highway;
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to any parking place of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984;
- (b) the vehicle to be used in pursuance of statutory powers or duties;
 - (c) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
 - (d) the vehicle to be used for fire brigade, ambulance or police purposes.

5. A driver of a vehicle shall not use a parking place:-

- (a) so as unreasonably to prevent access to any premises adjoining the roads or the use of the roads by other persons, or so as to be a nuisance;
- (b) when for preventing obstruction of the streets the Council shall by order made on the occasion of any public procession, rejoicing illumination or when the streets are thronged or liable to be obstructed have closed that parking place and exhibited notice of such closing on or near the parking place.

6. In this Order:-

"parking place" means any part of a road authorised by this Order to be used as a parking place.

7. This Order shall come into operation on the 27 day of October 1997 and may be cited as The County of Hereford and Worcester (A438 High Street, Ledbury) (Parking Places for Disabled Persons Vehicles) Order 1997

**THE COUNTY OF HEREFORD AND WORCESTER (A438 HIGH STREET, LEDBURY)
(GOOD VEHICLE STREET PARKING PLACES) AND (PARKING PLACES FOR
DISABLED PERSONS VEHICLES) ORDER 1997**

On 11 September 1997 Hereford and Worcester County Council made an Order which will make permanent the existing Experimental Orders on A438 High Street, Ledbury and which will:

A. provide a goods vehicle loading bay on the east side of A438 High Street, Ledbury from point 40 metres north of its junction with A449 Worcester Road for a distance of 20 metres in a northerly direction. The length of stay shall not exceed 45 minutes (return prohibited within one hour) and shall operate between the hours of 7.00am and 2.00 pm, Monday to Saturday inclusive.

B. provide one parking place for a disabled persons vehicle on the east side of A438 High Street, Ledbury located 75 metres north of its junction with A449 Worcester Road for a distance of 3.6 metres in a northerly direction. The length of stay shall not exceed 45 minutes (return prohibited within one hour) and shall operate between the hours of 8.00 am and 6.00 pm, Monday to Saturday inclusive.

A copy of the Order, relevant map, Statement of Reasons for making the Order and affected existing regulations may be inspected at Malvern Hills District Council Offices Council House, Avenue Road, Malvern; Malvern Hills District Council Area Offices, St Katherine's, High Street, Ledbury and County Hall, Spetchley Road, Worcester, WR5 2NP during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court by 23 October 1997.
