# ROAD TRAFFIC REGULATION ACT 1967 4(0.05)

THE COUNTY OF HEREFORD AND WORCESTER

(HIGH STREET AND A449 WORCESTER ROAD, LEDBURY)

### (PROHIBITION AND RESTRICTION OF WAITING AND RESTRICTION OF LOADING AND UNLOADING) ORDER 1984

The County Council of Hereford and Worcester, in exercise of their powers under Section 1(1), (2) (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 (which said Act of 1967 as so amended is hereinafter referred to as 'the Act of 1967') and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

- 1. (a) The County of Hereford (Ledbury) (Traffic Regulation) Order 1955 is hereby varied and shall have effect as though waiting was prohibited on the south side of the A449 Worcester Road only.
  - (b) The Herefordshire County Council (Various Streets, Ledbury) (Prohibition and Restriction of Waiting) (Amendment) Order 1973 is hereby varied and shall have effect as though:-
    - (i) item 3 of Schedule 1 was amended to read:-

West side from the junction with Bye Street for a distance of 20 yards in a southerly direction.

(ii) item 2 of Schedule 2 was amended to read:-

<u>High Street</u>, West side - from a point 20 yards south of the junction with Bye Street for a distance of 13 yards in a southerly direction.

- 2. Save as provided in Articles 5 and 6 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait at any time in the sides of lengths of roads in the Town of Ledbury in the District of Malvern Hills in the County of Hereford and Worcester specified in the First Schedule to this Order.
- 3. Save as provided in Article 5 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to load and unload between the hours of 8.00 a.m. and 4.00 p.m. on Monday to Saturday inclusive in the side of length of road specified in the Second Schedule to this Order.
- 4. Save as provided in Articles 5 and 7 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait between the hours of

8.00 a.m. and 6.00 p.m. on Monday to Saturday inclusive on the side of length of road in the Jown of Ledbury in the District of Malvern Hills in the County of Hereford and Worcester specified in the Third Schedule to this Order:-

- (i) for a period exceeding 45 minutes; or
- (ii) if a period of less than one hour has elapsed since the termination during the said hours of the hours of the last period of waiting (if any) by that vehicle on the side of length of road.
- 5. Nothing in Articles 2, 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in the sides of lengths of roads referred to in those Articles for so long as may be necessary to enable:-
  - (a) a person to board or alight from the vehicle;
  - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the side
    - of lengths of roads referred to, or the laying, erection, alteration or repair in or near the said sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act 1878;
  - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
  - (e) the vehicle to be used for the purpose of delivering or collect ing postal packets as defined in Section 87 of the Post Office Act 1953;
  - (f) the vehicle to be used for the purpose of removing furniture and effects from one office or dwellinghouse to another, or to such premises from a depository or from such premises to a depository, provided notice is given twenty-four hours in advance to the police, their consent is obtained and such reasonable conditions as they may impose are complied with;
  - (g) the vehicle to be used for fire brigade, police or ambulance purposes.
  - (h) goods to be loaded onto and unloaded from the vehicle (except that length of road in Article 3 of the Order).
- 6. Nothing in Article 2 (except that length of road specified in Article 3 of this Order) shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the sides of lengths of road referred to in those Articles for a period not exceeding two hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same sides of lengths of roads on the same day).

- 7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled persons vehicle which displays in the relevent postion a disabled person's badge to wait in the side of length of road referred to in that Article.

"disabled person's badge" has the same meaning as in The Disabled Person's (Badges for Motor Vehicles) Regulations 1975; "disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemption for Disabled Persons) (England and Wales) (Amendment) Regulations 1975;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No. 4631 : 1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.

For the purpose of this Order a vehicle shall be regarded as displaying:-

(a) a disabled person's badge in the relevant position, when -

- (i) in the case of a vehicle fitted with a front wind screen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen; and
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle;
- (b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- 6. This Order shall come into operation on the8th day of February 1984 and may be cited as The County of Hereford and Worcester (High Street and A449 Worcester Road, Ledbury) (Prohibition and Restriction of Waiting and Restriction of Loading and Unloading) Order 1984.



#### FIRST SCHEDULE

Sides of lengths of roads in the Town of Ledbury in the District of Malvern Hills in the County of Hereford and Worcester.

A449 Worcester Road north side

High Street west side from the junction with High Street for a distance of 138 metres (453 feet) in an easterly direction.

from the junction with New Street for a distance of 44 metres (144 feet) in a northerly direction.

from the junction with A449 Worcester Road for a distance of 15 metres (49 feet) in a northerly direction.

#### SECOND SCHEDULE

Side of length of road in the Town of Ledbury in the District of Malvern Hills in the County of Hereford and Worcester.

High Street west side

from the junction with New Street for a distance of 12 metres (40 feet) in a northerly direction.

## THIRD SCHEDULE

Side of length of road in the Town of Ledbury in the District of Malvern Hills in the County of Hereford and Worcester.

High Street east side

west side

from a point 15 metres (49 feet) north of the junction with A449 Worcester Road for a distance of 70 metres (231 feet) in a northerly direction.

from a point 44 metres (144 feet) north of its junction with New Street for a distance of 52 metres (171 feet) in a northerly direction.

east side
