## (CLEARWAY) (NO. 1 ) ORDER 1979

## BYE STREET AND HIGH STREET, LEDBURY

The County Council of Hereford and Worcester in exercise of their powers under Section 1(1), (2), (3), (3B) and (6) of the Road Traffic Regulation Act 1967, as amended by Fart IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967"), and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the Act of 1967, hereby make the following Order:-

1. In this Order, the following expressions have the meanings hereby assigned to them respectively, that is to say -

"the Traffic Signs Regulations" means the Traffic Signs Regulations and General Directions 1975;

"prohibited area", in relation to the lengths of road specified in the Schedule hereto, means all those areas of carriageway of the road bounded by the uter line of a road marking shown in Diagram 1025.1 to the Traffic Signs Regulations and for the time being lawfully in place, and along which area is placed a road marking in the form of a yellow line adjacent to the edge of the carriageway;

"scheduled express carriage" means an express carriage as defined in Section 117 of the Road Traffic Act 1960 operated in accordance with a timetable attached as a condition to a road service licence issued under Section 134 of the said Act of 1960.

- 2. Save as provided in Article 3 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform, or a Traffic Warden, cause or permit any vehicle, other than a stage carriage or a scheduled express carriage to wait between the hours of 7.00 a.m. and 7.00 p.m. in any prohibited area in the lengths of road specified in the Schedule horeto.
- 3. Nothing in Article 2 of this Order shall render it unlawful for a person to cause or permit a vehicle to wait in any prohibited area if the vehicle:
  - (a) is being used for the removal of any obstruction to traffic; or
  - (b) is being used in the service of the Council or with the permission of the Council in exercise of statutory powers or duties and whilst being so used in such service it is necessary for the vehicle to wait in the whole the waiting.

- (c) is being used for fire brigade, ambulance or police purposes; or.
- (d) in any case where the person in control of the vehicle is required by law to stop, or is obliged to do so in order to avoid an accident, or is prevented from proceeding by circumstances outside his control;
- (e) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road referred to or the laying, crection, alteration or repair in or near to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act 1878;
- (f) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the pursuance of statutory powers or duties.
- 4. The Council are satisfied that for facilitating the passage of vehicular traffic on the road to which this Order relates, it is requisite that Section 1(5) of the Act of 1967 should not apply in relation to this Order.
- 5. This Order shall come into operation on the 31st day of July 1979, and may be cited as the County of Hereford and Worcester (Bus Stops) (Clearway) (No. 1 ) Order 1979.

## BYE STREET AND HIGH STREET, LEDBURY

The County Council of Hereford and Worcester in exercise of their powers under Section 1(1), (2), (3), (3B) and (6) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967"), and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the Act of 1967, hereby make the following Order:-

1. In this Order, the following expressions have the meanings hereby assigned to them respectively, that is to say -

"the Traffic Signs Regulations" means the Traffic Signs Regulations and General Directions 1975;

"prohibited area", in relation to the lengths of road specified in the Schedule hereto, means all those areas of carriageway of the road bounded by the uter line of a road marking shown in Diagram 1025.1 to the Traffic Signs Regulations and for the time being lawfully in place, and along which area is placed a road marking in the form of a yellow line adjacent to the edge of the carriageway;

"scheduled express carriage" means an express carriage as defined in Section 117 of the Road Traffic Act 1960 operated in accordance with a timetable attached as a condition to a road service licence issued under Section 134 of the said Act of 1960.


- 2. Save as provided in Article 3 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform, or a Traffic Warden, cause or permit any vehicle, other than a stage carriage or a scheduled express carriage to wait between the hours of 7.00 a.m. and 7.00 p.m. in any prohibited area in the lengths of road specified in the Schedule hereto.
- 3. Nothing in Article 2 of this Order shall render it unlawful for a person to cause or permit a vehicle to wait in any prohibited area if the vehicle:
  - (a) is being used for the removal of any obstruction to traffic; or
  - (b) is being used in the service of the Council or with the permission of the Council in exercise of statutory powers or duties and whilst being so used in such service it is necessary for the vehicle to wait in the place where it is waiting:

- (c) is being used for fire brigade, embulance or police purposes; or
- (d) in any case where the person in control of the vehicle is required by law to stop, or is obliged to do so in order to avoid an accident, or is prevented from proceeding by circumstances outside his control;
- (e) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road referred to or the laying, erection, alteration or repair in or near to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act 1878;
- (f) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the pursuance of statutory powers or duties.
- 4. The Council are satisfied that for facilitating the passage of vehicular traffic on the road to which this Order relates, it is requisite that Section 1(5) of the Act of 1967 should not apply in relation to this Order.
- 5. This Order shall come into operation on the 31st day of July 1979, and may be cited as the County of Hereford and Worcester (Bus Stops) (Clearway) (No. 1) Order 1979.
