## **ROAD TRAFFIC REGULATION ACT 1984**

## COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL

# (A44 MILL STREET & LUDLOW ROAD, LEOMINSTER) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 2006

The County of Herefordshire District Council ("the Council") in exercise of its powers under sections 1 and 2 of the Road Traffic Regulation Act 1984 (referred to as "the Act"), the Road Traffic Act 1991 (as amended) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 of the Act of 1984, hereby make the following Order:-

- 1. This Order shall come into operation on 6<sup>th</sup> day of February 2006 and may be cited as the County of Herefordshire District Council (A44 Mill Street & Ludlow Road, Leominster) (Prohibition and Restriction of Waiting) Order 2006.
- 2. (1) In this Order:-

"Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 2000;

"Disabled Persons Vehicle" means a vehicle displaying a Disabled Persons Badge and Parking Disc.

"Parking Attendant" means a person appointed in accordance with the provisions of Section 63A of the 1984 Act.

"Parking Disc" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
  - (a) a disabled person's badge in the relevant position, when:-
    - (i) in the case of a vehicle fitted with a dashboard or fascia panel, the badge is exhibited thereon so that the front of the badge is legible from outside the vehicle; and
    - (ii) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle so that the front of the badge is legible from outside the vehicle.
  - (b) a Parking Disc in the relevant position, when:-
- (i) in the case of a vehicle fitted with a dashboard or fascia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; and
- (ii) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the

period of waiting began is legible from outside the vehicle.

- 3. Save as provided in Article 5 and 6 of this Order no person shall, except upon the direction or with the permission of a police officer or Parking Attendant in uniform cause or permit any vehicle to wait at any time on those lengths of road specified in Schedule 1 to this Order and which for the purposes of identification only are shown on the attached plan.
- 4. No person shall, except upon the direction or with the permission of a police officer or Parking Attendant in uniform cause or permit any vehicle to wait other than those vehicles stated and for the maximum period stated on those lengths of road specified in Schedule 2 to this Order and which for the purposes of identification only are shown on the attached plan.
- 5. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in the sides of those lengths of road referred to in Schedule 1 for so long as may be necessary to enable:-
  - (a) a person to board or alight from the vehicle;
  - (b) goods to be loaded onto and/or unloaded from the vehicle;
  - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the side of those lengths of road referred to, or the laying, erection, alteration or repair in or near the said sides of those lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
  - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
  - (e) the vehicle to be used for the purpose of delivering or collecting postal packets;
  - (f) the vehicle to be used for the purpose of removing furniture and effects from one office or dwellinghouse to another, or to such premises from a depository or from such premises to a depository, provided notice is given twenty-four hours in advance to the police, their consent is obtained and such reasonable conditions as they may impose are complied with;
  - (g) the vehicle to be used for fire brigade, police or ambulance purposes.
- 6. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a Disabled Person's Vehicle which displays in the relevant position a Disabled Person's Badge, and a Parking Disc (on which has been marked the time at which the period of waiting began) to wait in the said sides of those lengths of road referred to in Article 3 for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same sides of length of road on the same day).
- 7. The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.

# **NO WAITING AT ANY TIME**

## A44 Mill Street & Ludlow Road

#### North Side

- from a point 121 metres west of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to a point 124 metres east of that point
- ii) from a point 193 metres east of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to its junction with the A49.

#### South Side

- from a point 110 metres west of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to a point 127 metres east of that point.
- ii) from a point 189 metres east of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to its junction with the A49.

#### **SCHEDULE 2**

VEHICLES EXCEEDING EITHER 44 TONNES MAXIMUM GROSS WEIGHT, 18.75 METRES IN LENGTH, 2.9 METRES IN WIDTH OR TRAVELLING AT 5 MILES PER HOUR OR LESS ARE PERMITTED TO WAIT FOR A MAXIMUM PERIOD OF 30 MINUTES (UNLESS WAITING FOR PERMISSION TO PROCEED OR DENIED PASSAGE OVER CROSSING).

## A44 Mill Street & Ludlow

#### North Side

- i) from a point 121 meters west of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to a point 187 metres west of that point.
- ii) from a point 124 metres east of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to a point 193 metres east of that point.

#### South Side

- i) from a point 110 metres west of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to a point 149 metres west of that point.
- ii) from a point 127 metres east of the centre line of the level crossing of the Newport to Shrewsbury railway (Leominster to Ludlow section) to a point 189 metres east of that point.
