

ROAD TRAFFIC REGULATION ACT 1984

HEREFORDSHIRE COUNCIL

**(U80332 BLACKFRIARS STREET HEREFORD)
(PROHIBITION OF WAITING, LOADING AND UNLOADING AT ANY TIME) ORDER 2014**

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under sections 1 and 2 of the Road Traffic Regulation Act 1984 (referred to as "the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on the 4th day of *APRIL* 2014 and may be cited as Herefordshire Council (U80332 Blackfriars Street Hereford) (Prohibition of Waiting, Loading and Unloading at Any Time) Order 2014.
2. (1) In this Order:-

"Civil Enforcement Officer" means a person appointed in accordance with the provisions of Section 76 of the Traffic Management Act 2004.
3. Save as provided in Article 4 of this Order no person shall, except upon the direction or with the permission of a police officer or of a Civil Enforcement Officer in uniform, cause or permit any vehicle to wait, load and unload at any time on the lengths of road as mentioned in the Schedule hereto and as shown for identification purposes only on the attached plan.
4. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in the sides of those lengths of road referred to in Article 3 for so long as may be necessary to enable:-
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used for the delivery or removal of plant/or materials for any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the side of those lengths of road referred to, or the laying, erection, alteration or repair in or near the said sides of those lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Communications Act 2003 (as amended);
 - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
 - (e) the vehicle to be used for the purpose of delivering or collecting postal packets.
 - (f) the vehicle to be used for the purpose of removing furniture and effects from one office or dwelling house to another, or to such premises from a depository or from such premises to a depository, provided notice is given twenty-four hours in advance to the police and /or the Council, their consent is obtained and such reasonable conditions as they may impose are complied with;
 - (g) the vehicle to be used for fire brigade, police or ambulance purposes.
 - (h) the vehicle to be used for the purposes of collecting waste or recyclables or street cleansing.
5. The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the provisions in the following traffic regulation order that relate to the lengths of road subject to this Order which are in operation prior to the date mentioned in Article 1 hereto will be revoked in their entirety from the date mentioned in the said Article 1:

7. References to any statutory provision herein shall include reference to any statutory modification or re-enactment thereof.

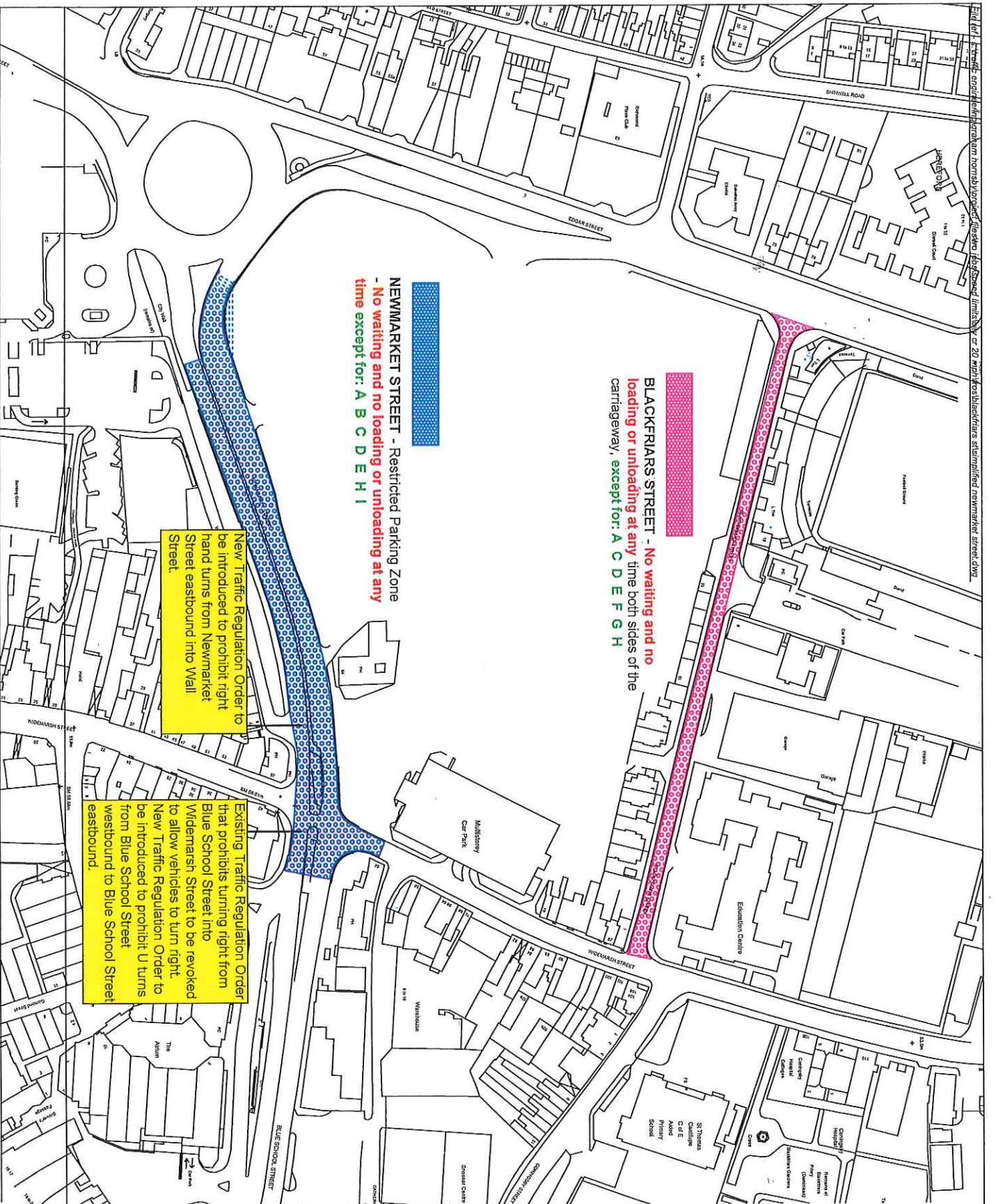
SCHEDULE

Prohibition of Waiting, Loading and Unloading at Any Time

U80332 Blackfriars Street Hereford

North side and South side

For its entire length between its junction with the eastern kerb line of the A49 Edgar Street and its junction with the western kerb line of the B4359 Widemarsh Street



NEWMARKET STREET - Restricted Parking Zone
 - No waiting and no loading or unloading at any time except for: A B C D E H I

BLACKFRIARS STREET - No waiting and no loading or unloading at any time both sides of the carriageway, except for: A C D E F G H

New Traffic Regulation Order to be introduced to prohibit right hand turns from Newmarket Street eastbound into Wall Street.

Existing Traffic Regulation Order that prohibits turning right from Blue School Street into Widemarsh Street to be revoked. New Traffic Regulation Order to be introduced to prohibit U turns from Blue School Street westbound to Blue School Street eastbound.

NO WAITING AND NO LOADING OR UNLOADING AT ANY TIME EXCEPT FOR:
 See main drawing for exemptions to this prohibition applicable to each street.

- A. Passengers boarding or alighting from a vehicle.
- B. Public Service Vehicles waiting at an authorised stopping place for passengers to board or alight.
- C. Vehicles being used in connection with building or demolition works, highway maintenance or works in connection with services.
- D. Vehicles being used in pursuance of statutory powers or duties.
- E. Vehicles being used for Fire Brigade, Police or Ambulance purposes.
- F. Vehicles being used to deliver mail or deliver or collect parcels.
- G. Vehicles being used for furniture removals.
- H. Vehicles being used for the collection of waste, refuse, recyclables or street cleansing.

- 1. Pedal cycles parked at a recognised cycle stand.
