**THE BOROUGH OF HERTSMERE

Order 2007**

Hertsmere Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of The Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council ("the County Council") and in exercise of the powers conferred by Sections 1-4, 32 and 35, 45, 46, 49, 51 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended by the Road Traffic Regulation (Parking) Act 1986) and Section 43 and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act has made the following Order:-

1. This Order shall come into operation on 6 August 2007 and may be cited as "The Borough of Hertsmere (Potters Bar Controlled Parking Zone) (Amendment No. 1) Order 2007" hereinafter referred to as "this Order".
2. The provisions of the following Order are hereby revoked only in so far as they are affected by the restrictions imposed by this Order:

The Borough of Hertsmere (Control of Parking) (Consolidation) Order 2007.

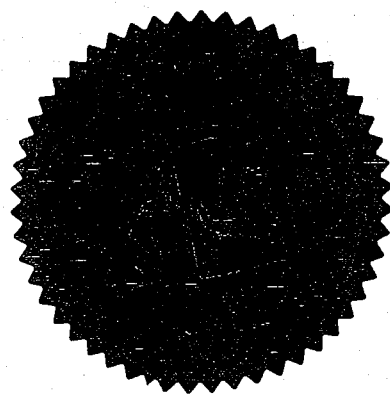
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, The Borough of Hertsmere (Control of Parking) (Consolidation) Order 2007 (hereinafter called "the 2007 Order") shall have effect so as to substitute the items in the Schedule to this Order for corresponding items in Schedule 2 of the 2007 Order.
5. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.

Residents Permits	First permit = Free of charge, second = £30, third = £60, fourth = £90 (Maximum of 4 permits per household)
Duplicate Residents Permit	£15
Business Permits	£400 per annum, £230 per 6 months and £120 per 3 months.
Refund of charge in respect of Business Permit	Annual permit = 50% of initial cost for each complete 6 months unexpired. 6 months permit = 50% of initial cost for each complete 3 months unexpired. 3 months permit = no refund.

Visitors Parking Vouchers	£5 per 20 half-day vouchers
Visitors Annual Permits	£20
School Permits	£10
Refund of charge in respect of School Permit	50% of initial cost if surrendered before it becomes valid, no refund applicable if surrendered after it becomes valid.

Exemption Permits	Free of charge.
Duplicate Exemption Permit	£10
Special Permits	£25 per annum
Duplicate Special Permit	£15

**STATEMENT OF REASONS**

To amend the current on street car-parking charges in Potters Bar in order that decriminalisation becomes self-financing as soon as possible in accordance with Government advice.

To improve car-parking management, reduce congestion and to allow shoppers and short stay visitors to park on street in the main shopping areas of Potters Bar for periods of up to two hours similar to that which operates successfully in other parts of the Borough.
