

**ROAD TRAFFIC REGULATION ACT 1984  
IPSWICH BOROUGH COUNCIL (CIVIL ENFORCEMENT AREA)  
(WAITING RESTRICTIONS AND ON-STREET PARKING PLACES)  
(ZONE 2) (AMENDMENT) ORDER 2009E [Sealed as Revision 18]**

WHEREAS IPSWICH BOROUGH COUNCIL wishes to amend certain aspects of the Ipswich Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Loading Restrictions, Loading Areas and On-Street Parking Places) (Consolidation) Order 2005, as amended, and of the Ipswich Borough Council (Civil Enforcement Area) (Waiting Restrictions and On-Street Parking Places) (Zone 2) (Amendment) Order 2008C, by:-

- (1) substituting an amended version of Map Schedule P6 (the amendments relate to the section of Orford Street between the junctions with Alpe Street and Cardigan Street only) and
- (2) clarifying the position concerning the types of vehicle for which residents parking places in Zone 2 may be used.

IPSWICH BOROUGH COUNCIL pursuant to arrangements made in accordance with Regulations made under Section 19 of the Local Government Act 2000 with the Suffolk County Council in exercise of the powers of the County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 Part III of the Act and Part 6 of the Traffic Management Act 2004 ("the 2004 Act") MAKES THE FOLLOWING ORDER:-


1. This Order may be cited as the Ipswich Borough Council (Civil Enforcement Area) (Waiting Restrictions and On-Street Parking Places) (Zone 2) (Amendment) Order 2009E and shall come into force on *3<sup>rd</sup> June 2009*.
2. The Ipswich Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Loading Restrictions, Loading Areas and On-Street Parking Places) (Consolidation) Order 2005, as amended, shall have effect in full as if the same had been set out in full herein, save for the following amendment:-  
  
The attached amended version of Map Schedule P6 shall be substituted for the existing version.
3. The Ipswich Borough Council (Civil Enforcement Area) (Waiting Restrictions and On-Street Parking Places) (Zone 2) (Amendment) Order 2008C shall have effect in full as if the same had been set out in full herein, save for the following amendments:-

(a) In Article 2.2, the words "passenger vehicles, goods vehicles, motor cycles or invalid carriages" shall be substituted for the existing list of vehicles.

(b) In Article 2.4, the words "disabled persons badge" and "badge" shall be deleted.

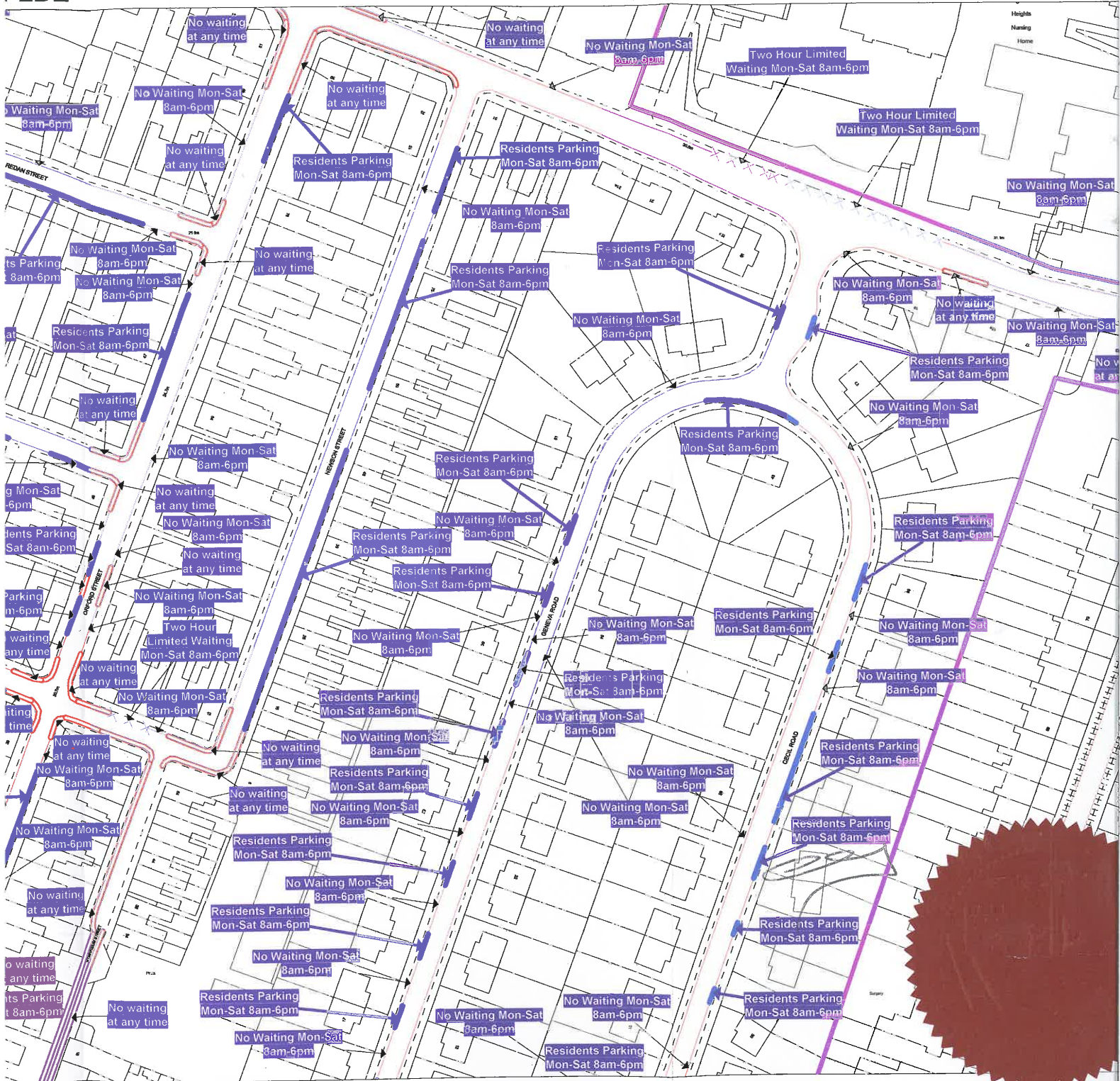
