

GORCHYMYN RHIF 2 CYNGOR SIR YNYS MÔN /
ISLE OF ANGLESEY COUNTY COUNCIL
(BIWMARES, CAERGYBI, GAERWEN A
LLANERCHYMEDD) (SAFLEOEDD PARCIO I

Yn unol â'i bwerau dan Adran 32(1) a 35(1) a Rhan IV Atodlen 9 Deddf Rheoli Trafnidiaeth y Ffyrdd 1984 (y cyfeirir ati o hyn allan fel "y Ddeddf") a'r holl bwerau galluogol eraill; ar ôl ymgynghori â Phrif Swyddog yr Heddlu, yn unol â Rhan III Atodlen 9 y Ddeddf, mae Cyngor Sir Ynys Môn / Isle of Anglesey County Council (y cyfeirir ato o hyn allan fel "y Cyngor") drwy hyn yn gwneud y Gorchymyn isod:-

1. Daw'r Gorchymyn hwn i rym ar y 1^{af} dydd o fis Chwefror dwy Fil a wyth a gellir ei ddyfynnu fel "Gorchymyn Rhif 2 Cyngor Sir Ynys Môn / Isle of Anglesey County Council (Biwmares, Caergybi, Gaerwen a Llanerchymedd) (Safleoedd Parcio i Bersonau Anabl) 2008.

2. Yn y Gorchymyn hwn:-
golyga "gyrrwr", mewn perthynas â cherbyd sy'n aros mewn lle parcio y person a oedd yn gyrrwr cerbyd ar yr adeg y'i gadawyd yn y lle parcio.

golyga "lle parcio" unrhyw ran o'r ffordd a awdurdodir gan y Gorchymyn hwn i'w defnyddio fel lle parcio.

golyga "perchennog", mewn perthynas â cherbyd, y person sy'n cadw ac yn defnyddio'r cerbyd.

golyga "cerbyd person anabl" cerbyd yn arddangos yn gyfreithlon bathodyn person anabl.

mae i "bathodyn person anabl" yr un ystyr ag sydd i "disabled person's badge" yn Rheolau (Bathodynnau i Gerbydau Modur) (Cymru) Pobl Anabl 2000.

golyga "safle perthnasol":-

(1) yn achos cerbyd modur sydd â ffenest flaen, fod y bathodyn wedi'i arddangos arni gyda'r tu ôl yn wynebu ymlaen ar ochr chwith y ffenest ac yn union y tu ôl iddi;

(2) yn achos cerbyd heb ffenest flaen, fod y bathodyn wedi'i arddangos mewn lle amlwg ar flaen neu ochr chwith y cerbyd.

PARKING PLACES) No 2 ORDER 2008

Cyngor Sir Ynys Môn / Isle of Anglesey County Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 32(1) and 35(1) and Part IV of Schedule 9 of the Road Traffic Regulations Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This order shall come into operation on the 1st day of February two thousand and eight and may be cited as "The Cyngor Sir Ynys Môn / Isle of Anglesey County Council (Beaumaris, Holyhead, Gaerwen and Llanerchymedd) (Disabled Persons Parking Places) No 2 Order 2008.

2. In this Order:-

"driver" in relation to a vehicle waiting in a parking place means the person driving the vehicle at the time when it was left in the parking place.

"parking place" means any part of the road authorised by this Order to be used as a parking place.

"owner" in relation to a vehicle means the person by whom such vehicle is kept and used.

"disabled person's vehicle" means a vehicle lawfully displaying a disabled persons badge.

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000.

"relevant position" means:-

(1) in the case of a motor vehicle fitted with a front windscreens, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreens;

(2) in the case of a vehicle not fitted with a front windscreens the badge is exhibited in a conspicuous position on the front or near side of the vehicle.

3. (1) Awdurdodir defnyddio'r rhan o'r ffordd a bennir yn Ngholofn Gyntaf yr Atodlen i'r Gorchymyn hwn, sydd wedi'i gylchu/farcio'n ddu ar y cynlluniau sydd ynghlwm fel lle parcio, yn y safleoedd hynny a bennir mewn perthynas â'r ffordd honno yn yr Atodlen ddywedig, y cyfryw ddosbarthiadau o gerbydau a bennir yno hefyd sy'n arddangos, yn y safle perthnasol, fathodyn person anabl.

(2) Ni fydd dim ym mharagraff (1) yn yr Erthygl hwn yn cyfyngu pwer y Cyngor i gau unrhyw le parcio.

4. Yn yr Atodlen i'r Gorchymyn hwn, lle ddisgrifir lle parcio fel un sydd "ar gael i gerbydau o ddosbarth arbennig" neu "yn y safle penodol", ni fydd gyrrwr y cerbyd yn caniatau iddo aros yn y lle parcio hwnnw onid yw:-

- (a) yn perthyn i'r dosbarth arbennig; neu yn ol yr achos
- (b) yn y safle penodol

5. Ni chaif gyrrwr y cerbyd ddefnyddio'r lle parcio pan fo'r Cyngor wedi cau'r lle parcio hwnnw.

6. Rhaid i yrrwr y cerbyd sy'n ddefnyddio'r lle parcio diffodd yr injan cyn gynted ag y bo'r cerbyd yn ei safle yn y lle parcio, ac ni chaiff gychwyn yr injan ond pan fo ar fin newid safle'r cerbyd yn y lle parcio neu i fynd o'r lle parcio.

7. Lle gadewir cerbyd mewn lle parcio yn groes i unrhyw rai o'r darpariaethau a geir yn y Gorchymyn hwn, caiff person a awdurdodwyd gan y Cyngor i wneud hynny symud y cerbyd neu drefnu iddo gael ei symud o'r lle parcio hwnnw.

8. Caiff unrhyw berson a fo'n symud cerbydau neu'n newid ei safle drwy rinwedd Erthygl 7 yn y Gorchymyn hwn wneud hynny yn y fath fodd a fo, yn ôl ei dyb, yn angen-rheidiol.

9. Lle bo person a awdurdodwyd gan y Cyngor yn symud neu'n trefnu i symud cerbyd o'r lle parcio drwy rinwedd Erthygl 7 neu 8 i'r Gorchymyn hwn, bydd yn trefnu yn ôl yr angen i'r cerbyd gael ei gadw yn ddiogel.

10. Pan fo bathodyn person anabl wedi'i arddangos ar gerbyd yn y lle perthnasol yn unol â darpariaethau'r Gorchymyn hwn, ni chaiff neb symud y cerbyd o'r lle parcio onid yw gyrrwr y

3. (1) The part of the roads specified in the First Column of the Schedule to this Order and shown circled/mark in black on the plans annexed hereto are authorised to be used, subject to the following provisions of this Order, as parking places for the parking in such positions as are specified in relation to that road in the said Schedule of such classes of vehicles also so specified as display in the relevant position a disabled person's badge.

(2) Nothing in paragraph (1) of this Article shall restrict the power of the Council to close any parking place.

4. Where in the Schedule to this Order a parking place is described as "available for vehicles of a specified class" or "in the specified position" the driver of the vehicle shall not permit it to wait in the parking place unless it is:-

- (a) of the specified class; or as the case may be
- (b) in the specified position.

5. The driver of the vehicle shall not use the parking place when the Council have closed that parking place.


6. The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and not start the engine except when about to change the position of the vehicle in or to depart from the parking place.


7. Where a vehicle is left in a parking place in contravention of any of the provisions contained in this Order, a person authorised by the Council to do so may remove the vehicle or arrange for it to be removed from that parking place.

8. Any person removing a vehicle or altering its position by virtue of Article 7 of this Order may do so in such manner as he thinks necessary.

9. Where a person authorised by the Council removes or makes arrangements of a vehicle from a parking place by virtue of Articles 7 and 8 to this Order he shall make arrangements as may be necessary for the safe custody of the vehicle.

10. Where a disabled person's badge has been displayed on a vehicle in the relevant position in accordance with the provisions of this Order no person shall remove the vehicle
