## THE NORFOLK COUNTY COUNCIL (HEACHAM, VARIOUS ROADS) (TRAFFIC REGULATION) CONSOLIDATION ORDER 2012

The Norfolk County Council in exercise of their powers under Sections 1(1) 2(1) to (3) and 3(2) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

- 1. Save as provided in Article 2, no person shall, except upon the direction of, or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause any vehicle to proceed along the U22266 King's Lynn Road adjacent to the main carriageway from a point 104 metres north-west of the western channel of its junction with the A149 Redgate Hill northwards for a distance of 84 metres.
- 2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing a vehicle to proceed in the lengths of road specified in that Article if the vehicle being used:
  - (a) is for fire brigade, police or ambulance purposes;
  - is in the service of a local authority or water authority in pursuance of statutory powers or duties;
  - (c) is in connection with the maintenance, improvement or reconstruction of that length of road or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer, water, gas, or electricity apparatus or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
  - (d) is for the provision of a universal postal service as defined in the Postal Services Act 2000;
  - (e) requires access to private property situated along and adjacent to the length of road specified in Article 2 of this Order.
- 3. Save as provided in Article 4 of this Order no person shall drive or cause to be driven any vehicle along the lengths of road specified in Column 1 of the Schedule to this Order in any direction other than the direction specified in Column 2 of the Schedule to this Order.
- 4. Nothing in Article 3 of this Order shall apply to the driving of any mechanical road cleansing vehicle.
- No person shall, except upon the direction of, or with the permission of a police constable in uniform or of a traffic warden, cause any vehicle proceeding along the southbound carriageway of the A149 Lynn Road to make a 'U' turn into the northbound carriageway of the A149 Lynn Road at its junction with the C104 Lynn Road.

- 6. No person shall, except upon the direction of, or with the permission of a police constable in uniform or of a traffic warden, cause any vehicle proceeding along the southbound carriageway of the A149 Lynn Road to make a right turn into the westbound carriageway of the U22257 The Broadway.
- 7. No person shall, except upon the direction of, or with the permission of a police constable in uniform or of a traffic warden, cause any vehicle proceeding along the eastbound carriageway of the U22257 The Broadway to make a right turn into the southbound carriageway of the A149 Lynn Road.
- 8. This Order shall come into operation on the 2<sup>nd</sup> day of February 2012 and may be cited as The Norfolk County Council (Heacham, Various Roads)(Traffic Regulation) Consolidation Order 2012
- 9. The following Orders will become revoked on the date of commencement of this Order as follows:-
  - "The Norfolk County Council (Heacham U22266 Off Redgate Hill)(Prohibition of Driving) Order 2001" in its entirety;
  - "The County of Norfolk (Heacham)(Traffic Regulation) Order 1968" in its entirety;
  - "The Norfolk County Council (Hecham)(Traffic Management) Order 1994" Schedule 3 of that Order;
  - "The Norfolk County Council (Hecham)(Prohibition of Right Hand Turns) Order 2008" in its entirety;
  - "The Norfolk County Council (Heacham)(Prohibition of 'U' Turns) Order 2008" in its entirety;
- 10. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in this Order, that provision of this Order shall prevail.
