

**KIRKLEES COUNCIL**

**(ON STREET PARKING PLACES) (No. 3) (AMENDMENT) ORDER 2007**

The Council of the Borough of Kirklees (hereinafter referred to as “the Council”) in exercise of its powers under Sections 45, 46, 47, and 49 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and Part IV of Schedule 9 to the Act, Section 43 of and Schedule 3 to the Road Traffic Act 1991 (“the 1991 Act”), the Road Traffic (Permitted Parking Area and Specified Parking Area) (Metropolitan Borough of Kirklees) Order 2006 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and with those persons and organisations specified in the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. This Order shall come into force on the 7th day of January 2008 and may be cited as the “Kirklees Council (On Street Parking Places) (No. 3) (Amendment) Order 2007”.
2. Article (2) of the Kirklees Council (On Street Parking Places) (No.3) Order 2007 (hereinafter referred to as “the original Order”) shall be amended by the addition of the words “and any reference in this Order to a numbered Schedule is a reference to the Schedule bearing that number in this Order”.
3. The word “first” shall be inserted before the word “Schedule” wherever the latter word appears in the original Order.
4. A new Article 26 shall be inserted into the original Order as follows:-  
  
26. REVOCATIONS  
  
(1) The items listed in column 1 of the Second Schedule are hereby revoked to the extent stated in column 2 of the said Second Schedule.
5. The Schedule to the original Order shall be re-named “First Schedule”.
6. The wording set out in the Schedule to this Order shall be inserted into the original Order to form the Second Schedule to the original Order.

**STATEMENT OF REASONS**

On 19 September 2007 the Kirklees Council (On Street Parking Places) (No. 3) Order 2007 was made, to take effect on 24 September 2007, which designated lengths of Mulberry Street, Moldgreen, Huddersfield as parking places.

It has subsequently been noted that this Order did not include any reference to the need to revoke provisions in the Kirklees Metropolitan Council (On Street Parking Places) (Consolidation) Order 2004 which relate to parking places on the same road.

The proposed Order will rectify that omission and is not intended to have any other effect.
