

THE KIRKLEES COUNCIL (CIVIL ENFORCEMENT) (AMENDMENT) ORDER 2008

The Council of the Borough of Kirklees (hereinafter referred to as “the Council”) in exercise of their powers under the Road Traffic Act 1984 (“the Act”) together with all other enabling powers hereby makes the following Order:-

PART I

1. COMMENCEMENT AND CITATION

This Order shall come into effect on the 26th day of May 2008 and may be cited as the Kirklees Council (Civil Enforcement) (Amendment) Order 2008.

PART II

2. AMENDMENTS TO THE KIRKLEES COUNCIL (CIVIL ENFORCEMENT) ORDER 2008.

2.1 The Orders listed in the First Schedule to this Order shall be inserted in Column 1 of the First Schedule to the Kirklees Council (Civil Enforcement) Order 2008.

2.2 The Orders listed in the Second Schedule to this Order shall be inserted in the Third Schedule to the Kirklees Council (Civil Enforcement) Order 2008.

PART III

3. SUPPLEMENTARY AMENDMENT

3.1 The Kirklees Metropolitan Council (Traffic Regulation) (No 29) Order 2005 shall be amended by the inclusion of the following provisions:-

PART IV

4. CONTRAVENTIONS OF PROVISIONS OF ORDER

4.1 Where a vehicle is left in a parking place or in any road or length of road in contravention of any provision of this Order such contravention shall be dealt with in accordance with the provisions of the 2004 Act and any subordinate legislation made under it.

4.2 The amount of the penalty charge for a parking contravention and, where applicable, the charges for the removal, storage and disposal of a vehicle shall be as set from time to time by the enforcement authority in accordance with the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any re-enactment or replacement thereof and published by it.”

PART IV

4. GENERAL

4.1 Any reference in this Order to a Statute or Statutory Instrument shall include reference to any re-enactment or replacement thereof.
