KIRKLEES COUNCIL

(OFF STREET PARKING PLACES) (NO. 4) ORDER 2008

The Council of the Borough of Kirklees (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 33 and 35 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), Part 6 of the Traffic Management Act 2004 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Kirklees) Order 2006 together with all other enabling powers hereby makes the following Order:-

PART I

1. COMMENCEMENT AND CITATION

This Order shall come into operation on the 15th day of December 2008 and may be cited as the Kirklees Council (Off-Street Parking Places) (No. 4) Order 2008.

PART II

2. AMENDMENTS TO AN EXISTING ORDER

- 2.1 The Kirklees Metropolitan Council (Off Street Parking Places) Order 2004 (as amended), shall be amended by the insertion of the Schedule to this Order to form the Sixth Schedule to the 2004 Order.
- 2.2 The second paragraph of Article 9 of the Kirklees Metropolitan Council (Off Street Parking Places) Order 2004 (as amended), shall be amended by the addition of the words "or any vehicle used for the purposes of a Council approved car club".
- 2.3 Article 17 of the Kirklees Metropolitan Council (Off Street Parking Places) Order 2004 (as amended) shall be amended by the addition of the following words after the first lettered item (f):-

"and, in the case of an off street parking place listed in the Sixth Schedule,

- (g) a motor vehicle being used by a Council approved car club".
- 2.4 Article 17 of the Kirklees Metropolitan Council (Off Street Parking Places) Order 2004 (as amended) shall be amended by the addition of the following words after the second lettered item (f):-

"and, in the case of an off street parking place listed in the Sixth Schedule,

(g) exhibit a valid permit issued for the purpose of a Council approved car club so that it is facing forwards and can be easily seen from the front of the vehicle".
