

KIRKLEES COUNCIL

(ON STREET PARKING PLACES) (No. 2) ORDER 2011

The Council of the Borough of Kirklees (hereinafter referred to as “the Council”) in exercise of its powers under Sections 45, 46, 47, and 49 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and Part 6 of the Traffic Management Act 2004, the Road Traffic (Permitted Parking Area and Specified Parking Area) (Metropolitan Borough of Kirklees) Order 2006 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and with those persons and organisations specified in the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. This Order shall come into force on the 30th day of May 2011 and may be cited as the “Kirklees Council (On Street Parking Places) (No. 2) Order 2011”.
2. The items in the First Schedule to the Kirklees Council (On Street Parking Places) (Consolidation) Order 2004 (hereinafter referred to as “the original Order”) which appear in Column 1 of the Schedule to this Order shall be amended as indicated in Column 2 of the Schedule to this Order.
3. The Orders referred to in the First Column of the Second Schedule to this Order are hereby revoked to the extent shown in the Second Column of that Schedule.
