

**KIRKLEES COUNCIL
(SPEED LIMIT) (NO 105) ORDER 2019
B6118 LILEY LANE, GRANGE MOOR
(30MPH SPEED LIMIT AND 40MPH SPEED LIMIT)**

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 81, 82 (2) and 84 (1) (a) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to lengths of road at Grange Moor in the Kirklees District.

SPEED LIMITS

1. No person shall drive any motor vehicle at a speed exceeding 30 mph on the length of the road specified in the First Schedule
2. No person shall drive any motor vehicle at a speed exceeding 40 mph on the length of the road specified in the Second Schedule

REVOCATIONS

3. The Order listed in the Third Schedule shall hereby be revoked to the extent set out in the Third Schedule.

GENERAL

4. Except where the context otherwise requires, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference to a numbered Schedule is a reference to the Schedule bearing that number in this Order.
5. Any reference to a Statute or Statutory Instrument in this Order shall include reference to any subsequent Statute or Statutory Instrument where the context requires it.
6. This Order shall come into effect on the 30th day of August Two Thousand and Twenty Two and may be cited as the "Kirklees Council (Speed Limit) (No.105) Order 2019".
